On July 16th, Uniform and Plainclothes Officers served a search warrant on Potrero Hill at a residence known to be frequented by gang members. Once inside the residence, officers detained numerous individuals. Please read below for more details.

On Tuesday, August 7th the San Francisco Police Department will participate in the annual National Night Out event. This event serves to promote crime and drug prevention, safety awareness, generate support for anti-crime programs, and strengthen police and community partnerships. Bayview Station is in the process of planning a National Night Out event for the Bayview Community. I will provide more details in the near future.

Because National Night Out falls on the regularly scheduled Captain's Community Meeting, I have rescheduled the meeting to Monday, August 6th at 6:00 pm in the Bayview Station Community Room.

Armed Robbery:

On July 16th at 10:55 am, a 19 year old victim came to Bayview Station to report that he had been robbed on July 14th on the **100 block of Harbor**. The victim stated that he was standing at the bus stop in the area when he was approached by three masked suspects. One of the suspects pointed a handgun at the victim while another suspect reached into the victim's pockets and removed his cell phone and wallet. The suspects then walked away. The victim was not injured as a result of the robbery. This incident is under investigation. (SFPD Case No. 120560227)

Shooting:

On July 16th at 9:14 am, officers responded to the area of 25th and Connecticut on multiple calls of shots fired. They arrived to find a 28 year old female victim that had been shot in the

leg on the **1000 block of Connecticut**. She was transported to SFGH and treated for her non life threatening injuries. Another victim, a 27 year old male, was dropped off at the hospital with a gunshot wound to his shoulder. He had also been on the 1000 block of Connecticut when the shooting occurred. Both victims were listed in stable condition.

The officers on the scene located spent bullet casings on the **900 and 1000 blocks of Connecticut**. They also located several parked vehicles that had been damaged as a result of the gunfire. The officers secured the crime scene and located witnesses to the incident. Crime Scene Investigations responded to the scene and collected all evidence. This incident is under investigation. (SFPD Case No. 120560073)

Robbery Attempt:

On July 16th at 7:20 pm, a victim came into Bayview Station to report a robbery attempt that had occurred on June 1st. The victim stated that he was walking home in the area of 3rd and Paul at 9:00 pm when a suspect across the street began shouting at him. The suspect asked the victim where he was from. The victim ignored the suspect and kept walking. The suspect caught up to him and grabbed him by the shoulder. The suspect swung the victim around and asked him what he had on him (in his pockets). The frightened victim did not reply. The suspect lifted his shirt and showed the victim that he had a handgun in his waistband and threatened to hit the victim with it. The suspect then apparently had a change of heart, told the victim that he was "cool" and fled the area. The victim was not injured as a result of this incident, which is under investigation. (SFPD Case No. 120561946)

Firearm, Parole Violation Arrest:

On July 16th, plainclothes officers were able to secure a search warrant for the person and home of a known "Zoo Block" gang member in response to the recent violent criminal activity in the Potrero Hill Housing Development. The officers executed a search warrant at the home on the **unit block of Turner Terrace**. The suspect was home along with six other people. Everyone was detained and identified. The suspect, currently on probation, had an active court order stipulating that he have no contact with any other gang members. Among the other individuals in the house was another documented "Zoo Block" gang member with a similar court order. He was on parole and also in violation of the order by associating with the suspect. Both gang members were placed under arrest for their respective court order violations. A search of the residence revealed a **loaded .25 caliber handgun** in one of the bedroom closets. The gun was seized pending further investigation. Both suspects were booked on their respective charges at Bayview Station. All of the other detained individuals were investigated and released from the scene. (SFPD Case No. 120562013)

DUI Arrest:

On July 16th at 9:50 pm, officers stopped a car in the area of **Silver and San Bruno** for swerving and driving on the wrong side of the street. They contacted the driver and from his appearance, speech, and the strong smell of alcohol on his breath, they suspected that he was intoxicated. The suspect admitted to having been drinking as well as not having a valid driver's license. The suspect failed all of the field sobriety tests and was placed under arrest. He was given a breath test with results exceeding the legal blood alcohol content of .08%. The suspect was booked for drunk driving and several vehicle code violations at county jail. Aggravated Assault:

On July 17th at 2:15 am, officers responded to a call of a fight in the area of **San Bruno and Silliman**. They met with the 25 year old victim and her husband. She stated that they had just left a night club in the area when a car pulled up beside them and the occupants started making lewd comments to her. All seven of the occupants of the car then got out and confronted the pair. One of the suspects hit the victim in the head, while another shattered the window of a nearby parked vehicle. Those two suspects then ran off on foot while the others got back into the car and drove away.

Other officers searched the area and located a car that matched the description of the suspect vehicle at **San Bruno and Silver**. They detained all five occupants but none could be positively identified at that time. All of the subjects were identified and released pending further investigation. The victim suffered a laceration to her forehead for which she was treated at SFGH.

Warrant Arrest:

On July 17th at 2:12 am, officers on the **1000 block of 22nd St**. saw a subject wandering in the area. Due to the time and fact that the area had suffered a rash of car burglaries recently, the officers made consensual contact with the subject and ran a record check. The suspect came back with an active \$40,000 narcotics warrant. He was taken into custody without incident and booked at Bayview Station. (SFPD Case No. 120369201)

Burglary:

The officers viewed the footage from the surveillance cameras in the establishment. The burglary had been captured on film. The suspect was seen entering the facility through the open roll up door. He was then seen opening the storage lockers and

removing items prior to leaving the warehouse. An inventory of stolen property is pending. This incident is under investigation. (SFPD Case No. 120565493)
