SUPERVISORS TO ALLOW THE BOARD OF SUPERVISORS TO CONSIDER, WITHOUT WAITING 30 DAYS AFTER ITS INTRODUCTION, THE ORDINANCE AMENDING ADMINISTRATIVE CODE CHAPTER 37 "RESIDENTIAL RENT STABILIZATION AND ARBITRATION ORDINANCE" BY ADDING A NEW SECTION 37.8C "TEMPORARY MORATORIUM ON RENT BOARD PROCESSING OR APPROVAL OF LANDLORD PETITIONS FOR CERTIFICATION AND PASSTHROUGH OF CAPITAL IMPROVEMENT. REHABILITATION AND ENERGY CONSERVATION COSTS TO TENANTS. DURING PENDENCY OF THE SUPERIOR COURT'S PRELIMINARY INJUNCTION STAYING IMPLEMENTATION OF NOVEMBER 2000 PROPOSITION H."

WHEREAS. The members of the Board of Supervisors wish to suspend the operation of Rule 5.43 with regard to the consideration of File 010060, establishing a temporary moratorium on the Rent Stabilization Board's processing or approval of landlords' requests for passthrough of capital improvement; now, therefore, be it

MOVED, That the Board of Supervisors of the City and County of San Francisco, as allowed by Rule 4.38 of its Rules of Order, hereby suspends the operation of Rule 5.43 of its Rules of orders from operating with regard to the Board's consideration of a proposed temporary moratorium on the processing of landlords' petitions for capital improvement by the Rent Stabilization Board.
