Motion releasing \$100,000 placed on Board of Supervisors Reserve for the Legal Assistance to Property Owners of Limited Means Program.

[Release of Reserve for Legal Assistance to Property Owners of Limited Means.]

WHEREAS, The Board of Supervisors, as part of the FY2000-2001 budget, approved \$100,000 for the development of a program to provide legal assistance to property owners of limited means: and,

WHEREAS, This money was included in the Mayor's Office of Economic Development's budget, allocated to the San Francisco Apartment Association, and placed on Board of Supervisors' reserve pending submittal of the program details; and

WHEREAS, The San Francisco Apartment Association, in concert with the Coalition for Better Housing, the San Francisco Association of Realtors, the Professional Property Management Association, Chinese Realtors of America and the Association of Homeowners, has developed a proposal which offers bi-lingual services to income-qualified property owners in San Francisco; and

WHEREAS, Legal services will focus on real property legal issues, specifically, but not limited to collection of delinquent rent, enforcement of covenants, and representation before city departments; and

WHEREAS, Many property owners of limited means have removed their units from the rental market, further impacting an already tight rental housing market, or cannot occupy their own home because their limited income cannot cover their legal fees; and

WHEREAS, A number individuals who would benefit from this program, for example the Galvez family whose situation has been chronicled in the local newspapers, have been

unable to access subsidized legal services, and have had to expend thousands of dollars to be able to legally move into their own homes; now, therefore, be it

FURTHER MOVED, That the San Francisco Apartment Association is requested to report back to the Finance Committee: by December 31, 2001, as to the results of the first six months of the new program, and, be it

FURTHER MOVED, That these released funds shall not be used for the purpose of tenant evictions based on owner move-ins or the Ellis Act.
