Board amendment deletions are strikethrough normal. Be it ordained by the People of the City and County of San Francisco: Section 1. The San Francisco Administrative Code is hereby amended by amending Section 2A.250, to read as follows: SEC. 2A.250. OFFICE DEPARTMENT OF THE CHIEF MEDICAL EXAMINER. (a) The Office of the Chief Department of the Medical Examiner. There shall be an aOffice Department of the Chief Medical Examiner. The City Administrator with the concurrence of the Mayor, shall appoint and may remove a *Chief* Medical Examiner who shall meet the qualifications for *Chief* Medical Examiner as provided by state law. The *Chief* Medical Examiner shall serve as a department head and appointing officer for the *Office Department*, and shall succeed to all of the duties of the Coroner. The Office department shall include such officers and employees as are authorized pursuant to the budgetary and fiscal provisions of the Charter. (b) **Duties and Functions.** The *Department Office of the Chief Medical Examiner* shall be responsible for the duties of the Medical Examiner as provided by state law, and such other duties and functions as assigned pursuant to the Charter or by ordinance.
