Section 1. Findings. (a) Pursuant to Planning Code Section 302, the Board of Supervisors finds that this ordinance will serve the public necessity, convenience and welfare for the reasons set forth in Planning Commission Resolution No. <u>17024</u>, and incorporates such reasons herein by reference. A copy of said Planning Commission resolution is on file with the Clerk of the Board of Supervisors in File No. <u>050299</u>

- (b) The Board of Supervisors finds that this ordinance is in conformity with the General Plan and the Priority Policies of Planning Code Section 101.1 for the reasons set forth in Planning Commission Resolution No. <u>17024</u>, and hereby incorporates those reasons by reference.
- (c) The Planning Department, on May 18, 2005, issued an Addendum to the Final Environmental Impact Report for the Waterfront Land Use Plan (SCH No. 94123007) (the "Final EIR") which has determined that the actions contemplated in this ordinance are in compliance with the California Environmental Quality Act (California Public Resources Code

(d) This Board, in Resolution No. 1161-97, endorsed the Planning Commission's certification of the Final EIR and adopted CEQA findings, which included the adoption of mitigation measures, a mitigation monitoring and reporting program, and a statement of overriding considerations, in connection with General Plan, Planning Code, and Zoning Map amendments related to the Waterfront Land Use Plan.
