(b) The General Manager of the Recreation and Park Department or the Recreation and Park Commission may grant permission to consume alcohol in the parks and portions of parks where such activity is prohibited by Subsection (a), above, if the General Manager or the Commission determines that the consumption of alcohol will not interfere with the public's use and enjoyment of the park. <u>However, neither the General Manager nor the Commission</u> <u>may grant permission to consume alcohol in children's play areas</u>.
