9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Findings.

11 The Planning Department has determined that the actions contemplated in this  
12 Ordinance are in compliance with the California Environmental Quality Act (California Public  
13 Resources Code section 21000 et seq.). Said determination is on file with the Clerk of the  
14 Board of Supervisors in File No. 110552 and is incorporated herein by reference.

16 Section 2. The San Francisco Park Code is hereby amended by amending Section  
17 12.14, to read as follows:

18 **SEC. 12.16. GOLF FEES—GOLDEN GATE PARK.**

19 The following use fees shall be charged for golfing at Golden Gate Park. Weekday hours  
20 are Monday through Friday, 12:00 PM. Weekend hours are Friday, 12:00 PM through Sunday.
