Ordinance retroactively authorizing the Office of the District Attorney to accept and expend a grant in the amount of \$287,624 from the California Office of Traffic Safety for the Alcohol and Drug Impaired Driver Vertical Prosecution Program, and amending Ordinance No. 147-14 (Annual Salary Ordinance, FYs 2014-2015 and 2015-2016) to reflect the addition of one grant-funded Class 8177 Attorney position (FTE 0.75) for the period of October 1, 2014, through September 30, 2015.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Findings

- (a) The Office of the District Attorney applied for funding from the State of California Office of Traffic Safety for the "Alcohol and Drug Impaired Driver Vertical Prosecution Program" and was awarded Two Hundred Eighty-Seven Thousand and Six Hundred Twenty-Four dollars (\$287,624).
 - (b) The award period is from October 1, 2014 to September 30, 2015.
 - (c) The grant does not include any provision for indirect costs.

Section 2. Authorization to accept and expend grant funds.

(a) The Board of Supervisors hereby authorizes the Office of the District
Attorney to retroactively accept and expend, on behalf of the City and County of San
Francisco, California Office of Traffic Safety grant funds in the amount of \$287,624 to

screen, investigate, prosecute, train, and raise public awareness on driving under the influence of alcohol and drugs.

(b) The grant does not include any provision for indirect costs and indirect costs are hereby waived.

Section 3. Grant funded positions; Amendment to Fiscal Years 2014-2015 and 2015-2016 Annual Salary Ordinance.

The hereinafter designated sections and items of Ordinance No. 147-14 (Annual Salary Ordinance FY 2014-2015 and FY 2015-2016) are hereby amended to add one (1) positions (0.75 FTE) in the Office of the District Attorney as follows:
