13 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. The appropriation of \$16,719,000 in Development Impact Fee revenues
16 does not emanate from the set aside that Charter section 8A.105 mandates. The City may
17 expend these revenues to address a variety of development impacts identified in the
18 ordinance imposing the impact fees. Therefore the appropriation of these funds is subject to
19 the full discretion of the Board of Supervisors to increase, decrease or eliminate by a simple
20 majority vote under Charter Section 9.103.

19 budget details to the Budget and Finance Committee.




