12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. The Administrative Code is hereby amended by revising Section 16.703, to  
14 read as follows:

15 **SEC. 16.703. HEALTH SERVICE SYSTEM; PLAN AND CONTRIBUTION RATES.**

16 Changes in contribution rates adopted by the Health Service Board, ~~as respect to~~ for the  
17 plans of the Health Service System, to become effective on January 1, 201~~6~~5 for the calendar  
18 plan year January 1, 201~~6~~5 through December 31, 201~~6~~5, approved by the Health Service  
19 Board in actions taken by it on June 11, 2015 ~~June 12, 2014~~, which plans and contribution rates  
20 are on file with the Clerk of the Board of Supervisors, are hereby approved.

21 Section 2. Effective Date. This ordinance shall become effective 30 days after  
22 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
23 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
24 of Supervisors overrides the Mayor's veto of the ordinance.


