WHEREAS, The Filipino Bar Association of Northern California, the San Mateo Legal Aid Society and the City of Daly City will be sponsoring a citizenship workshop to facilitate the application process for any airport security screener wishing to become an American citizen in order to maintain employment in their current positions; now, therefore, be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco commend the Filipino Bar Association of Northern California, the San Mateo Legal Aid Society and the City of Daly City for sponsoring a citizenship workshop in order to allow airport security screeners to maintain working in their current positions once the new Federal Aviation Security bill is implemented; and, be it
