WHEREAS, Continuum will benefit from Mr. Cloutier's experience in larger healthcare foundations as the organization moves toward more goal-oriented grants available through larger philanthropic healthcare organizations; now, therefore, be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco hereby commends Continuum for its outstanding service to our City and congratulates Mark Cloutier for his recent appointment as Executive Director of Continuum.
