Resolution authorizing the City and County of San Francisco to accept and expend State grant funds under the Per Capita Grant Program, in the amount of \$8,111,000, and under the Roberti-Z'berg-Harris Urban Open Space and Recreation Program Block Grant, in the amount of \$5,016,627, from the Safe Neighborhood Parks, Clean Water, Clean Air and Coastal Protection Bond Act of 2000; adopting findings pursuant to the California Environmental Quality Act; and adopting findings that such action is consistent with the City's General Plan and Eight Priority Policies of City Planning Code Section 101.1.

WHEREAS, The people of the State of California (the "State") enacted the Safe Neighborhood Parks, Clean Water, Clean Air, and Coastal Protection Bond Act (the "Bond Act"); and

WHEREAS, The State Legislature has enacted the Roberti-Z'berg-Harris Urban Open Space and Recreation Program Act (the "RZH Program"), which provides funds to certain political subdivisions of the State for acquiring lands and for developing facilities to meet urban recreational needs; and,

WHEREAS, The Bond Act provides funds for the Per Capita Grant Program, intended to provide safe, open and accessible local park and recreational facilities, and for the Roberti-Z'berg-Harris Block Grant Program, intended to implement the RZH Program, (collectively, the "Grant Programs") to be allocated to cities, counties and cities and counties within the State; and

Supervisor Hall, Daly BOARD OF SUPERVISORS WHEREAS, The State has approved a grant to the City and County of San Francisco (the "City") under the Per Capita Grant Program in the amount of \$8,111,000 and under the Roberti-Z'berg-Harris Block Grant Program in the amount of \$5,016,627, for a total of \$13,127,627 in Grant Program monies; and

WHEREAS, The Roberti-Z'berg-Harris Block Grant Program requires that the grantee provide a minimum local match, of monetary or certain non-monetary contributions, from non-State sources of thirty percent (30%) of the total project costs for which the grant under this program is used; and

WHEREAS, The City's Recreation and Park Department has determined that it can use the Grant Program monies described above for among other projects, the renovation of Harding Park and Fleming Golf Courses (the "Harding Park Renovation Project"), which is described in the Project Summary on file with the Clerk of the Board of Supervisors in File No. \_\_\_\_\_\_, which is hereby declared to be a part of this resolution as if set forth fully herein; and

WHEREAS, The City's Planning Commission issued a final Negative Declaration for the Harding Park Renovation Project on October <u>12</u> <u>30</u>, 2000, by Planning Commission Motion No. 16005 (the "Negative Declaration"), a copy of which is on file with the Clerk of the Board of Supervisors in File No. <u>020286</u>, which is hereby declared to be a part of this resolution as if set forth fully herein; and,

WHEREAS, The City's Planning Department issued an addendum ("Addendum #1") to the final Negative Declaration for the Harding Park Renovation Project on January 30, 2002, and another addendum (Addendum #2) to the final Negative Declaration for the Harding Park Renovation Project on March 15, 2002, copies of which are on file with the Clerk of the Board of Supervisors in File No. <u>020286</u>, which is hereby declared to be a part of this resolution as if set forth fully herein; and,
