Resolution extending the Transgender Civil Rights Implementation Task Force timeline to September 5th, 2002.

WHEREAS, The Transgender Civil Rights Implementation Task Force was formed to develop systemic policy recommendations to implement Citywide change in six areas, including employment, hate violence, law enforcement, housing, public accommodations/social services and medical provision; and,

WHEREAS, The implementation goals were based upon recommendations of a 1994 Human Rights Commission report; and,

WHEREAS, Since the formation of the task force, many of the recommendations from the 1994 report have been implemented; and,

WHEREAS, Some of the implemented actions include the adoption of San Francisco's employee health benefit for transgender care, the appointment of Theresa Sparks as San Francisco's first transgender Human Rights Commissioner, the passage of an employer notification law which requires all private employers in San Francisco to post the Human Rights Commission's poster outlining the city's non-discrimination policy (which includes transgender people), adoption by the Police Commission of recommendations made by the Office of Citizens Complaints to implement sensitivity training for all Police Officers and implement new policy protocols, the development by the Human Rights Commission of transgender policy protocols for the Sheriff's Department, and the hiring of new transgender staff at the HRC, among other changes; and,

WHEREAS, The task force was to perform its work from February 18th, 2000 through the following two years; and,

WHEREAS, The task force is in the process of making a final report but needs additional time to complete the project; and,

WHEREAS, The task force requires an extension of their operating timeline in order to complete their work; now, therefore be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco hereby extends the Transgender Civil Rights Implementation Task Force timeline to September 5th, 2002.
