WHEREAS, The terms of the agreement prohibit including indirect costs in the contract budget; now, therefore, be it

RESOLVED, That SFDPH is hereby authorized to enter retroactively into a Vendor Contract agreement in the amount of \$23,566 with UCSF, for services under the California HIV Incident Study; and, be it

FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the budget of the agreement; and, be it

FURTHER RESOLVED, That the Controller is directed to designate all positions funded under this agreement as "G" or grant-funded positions which would terminate when the agreement expires.
