[Commendation-WaterKeepers Northern California.]

Resolution commending WaterKeepers Northern California and its projects, San Francisco BayKeeper and DeltaKeeper, for making tremendous strides towards bringing agricultural discharges which harm our waterways under the regulatory umbrella and for continuing this effort with its Pesticide Use Reduction Enterprise.

WHEREAS. This year WaterKeepers won a promise by state regulators to cease the granting of arbitrary exemptions that allow pesticides and other pollutants to contaminate the Bay and the Delta; and,

WHEREAS, WaterKeepers won a superior court ruling that directed pesticides to be included in the State Water Board's Toxic Hotspots Cleanup Plan; and,

WHEREAS, DeltaKeeper won a two year limit for the development of pesticide cleanup plans under law, a deadline which the state board must now meet; and,

WHEREAS, This year Waterkeepers effectively challenged a State Water Board aquatic pesticide permit that regulates discharges of pesticides directly to waterways, winning \$2 million for pesticide impacts monitoring and \$600,000 to develop non-toxic alternatives; and.

WHEREAS, WaterKeepers continues to serve Northern California with its new campaign, the Pesticide Use Reduction Enterprise, which seeks to close a regulatory loophole that has allowed the destruction of aquatic resources, increases in cancers associated with pesticide-contamination, and the proliferation of water-borne and air-borne endocrine disrupters into neighborhoods and schoolyards miles from agricultural fields; now, therefore, be it
