WHEREAS, UCSF has agreed to reimburse SFDPH in the amount of \$36,991 under the terms of this agreement; and,

WHEREAS, As a condition of receiving the funds UCSF requires SFDPH to enter into a subcontract (The "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in File No. <u>021232</u>, which is hereby declared to be a part of this resolution as if set forth fully herein; and,

WHEREAS, The contract budget includes provision for indirect costs of \$3,963; now, therefore, be it

RESOLVED, That SFDPH is hereby authorized to enter retroactively into a subcontract agreement in the amount of \$36,991 with UCSF, the primary contractor, for services under the program entitled "A Randomized Trial of HIV Prevention in Harare Beerhalls"; and, be it

Department Of Public Health BOARD OF SUPERVISORS FURTHER RESOLVED, That the Director of Health is authorized to enter into the agreement on behalf of the City; and, be it

FURTHER RESOLVED, That the Controller is directed to designate the position funded under this agreement as a "G" or grant-funded position which would terminate when the agreement expires.
