## Resolution Urging the San Francisco Board of Supervisors to establish San Francisco as an Abuse Free Zone

WHEREAS, According to the United States Department of Justice, every 12 seconds a woman is beaten; and,

WHEREAS, The San Francisco Police Department receives approximately 9,500 domestic violence calls annually; and,

WHEREAS, According to the American Medical Association, nearly one-fourth of American women will be abused by a current or former partner at some point in their lives; and,

WHEREAS, Domestic violence and child abuse does not distinguish between class, culture, age, gender, sexuality, or locality; and,

WHEREAS, The Gender, Violence, and Resource Access Survey of transgender and inter-sex individuals, found that 50% of respondents had been raped or assaulted by a romantic partner, although only 62% of those raped or assaulted identified themselves as survivors of domestic violence when explicitly asked; and,

WHEREAS, Community United Against Violence (CUAV) estimates that for every police incident report on gay men's domestic violence that CUAV receives, there are between 10 and 20 incidents that go unreported; and,

WHEREAS, According to a report by the National Coalition of Anti-Violence Programs, violence in same sex relationships occurs at the same rate as in heterosexual relationships; and,

Supervisor Tom Ammiano , Daly San Francisco Board of Supervisors BOARD OF SUPERVISORS WHEREAS, In a study conducted by National Violence Against Women Prevention Research Center at the University of Missouri at St. Louis it was reported that about 17-45% of lesbians reported having been the victim of a least one act of physical violence perpetrated by a lesbian partner; and,

WHEREAS, The executive summary of the National Domestic Violence Media Campaign stated that children who witness domestic violence are 5 times more likely to become batterers or victims in their adulthood; and,

WHEREAS, From 1993-1998, women ages 16 to 24 experienced the highest per capita rates of intimate violence stated in the Bureau of Justice Statistics, May 2000; and,

WHEREAS, According to the Domestic Violence Project and the American Medical Association, at least 70% of men who batter their wives sexually or physically abuse their children; and,

WHEREAS, Stated in the National Institute of Justice and Bureau of Justice Statistics joint report, domestic violence often does not consist of a single incident; it is instead a continual state of victimization; and,

WHEREAS, The City and County of San Francisco need to acknowledge and address the effects of abuse and must respond to this crisis; therefore, be it

RESOLVED, That the San Francisco Youth Commission urges the San Francisco Board of Supervisors to declare San Francisco as an Abuse Free Zone.
