3 **Resolution approving an agreement between the City and County of San Francisco and**
4 **the Bay Area Rapid Transit District authorizing payment to San Francisco Municipal**
5 **Railway for transfer trips provided in FY2002 and FY2003.**

6 WHEREAS, The Municipal Railway's annual budget included payment from BART
7 estimated at \$2,438,000 for FY2002 and \$2,450,000 for FY2003; and

8 WHEREAS, The payments are based on a historical agreement whereby BART agrees
9 to reimburse MUNI to recognize that many BART patrons use MUNI for linkage to BART trips,
10 and that these patrons would not take BART at all were it not for the MUNI link; and

11 WHEREAS, Historically BART has based its payments to MUNI on the prior year's
12 payment with adjustments for changes in BART sales tax revenues; and

13 WHEREAS, MUNI and BART staff have agreed that the amount due to MUNI for
14 FY2002 is \$2,746,668 and for FY2003 is \$2,476,164; and

15 WHEREAS, On January 7, 2003, the Municipal Transportation Agency Board adopted
16 Resolution No. 03-010, authorizing the Director of Transportation to execute an agreement
17 with BART concerning the FY2002 and FY2003 transfer payments from BART to MUNI; and

18 WHEREAS, The Board of Supervisors has reviewed the proposed agreement, and
19 determined that BART's payments to MUNI increases MUNI's ability to provide feeder bus
20 transit service to BART stations, thus encouraging transit use and benefiting patrons of both
21 BART and MUNI; now, therefore be it

22 RESOLVED, That the Board of Supervisors hereby authorizes the Director of
23 Transportation to execute the attached Agreement with BART to effect the FY2002 and
24 FY2003 from BART to MUNI.


