[Authorizes the transfer of management oversight from the Mayor's Office of Disability and the

WHEREAS, The City granted \$51,706 in Community Development Block Grant ("CDBG") funds to the Third Street Economic Development Corporation, a nonprofit corporation (the "Third Street EDC"), in order to permit the Third Street EDC to acquire a property at 5048 Third Street (the "Property") for community purposes; and

WHEREAS, The Third Street EDC failed to use and maintain the Property in accordance with applicable CDBG regulations and instead transferred the Property to another nonprofit corporation in violation of its grant agreement with the City; and

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) has required the City to reimburse HUD \$475,000, the current fair market value of the Property, as a result of the failure to use and maintain the Property in accordance with applicable HUD regulations; and

WHEREAS the City can satisfy the reimbursement obligation through the transfer of management oversight of two previously approved projects that are CDBG eligible; and,

WHEREAS, Funds are being used for accessibility upgrades for the Silver Avenue Family Health Center (1525 Silver Avenue) and the Ocean Park Health Center (1351 24th Avenue); now, therefore be it

RESOLVED, That the City and County of San Francisco supports and authorizes the transfer of management oversight of \$205,000 in accessibility improvements for the Silver Avenue Family Health Center and \$270,000 in accessibility improvements at the Ocean Park Health Center facility from the Mayor's Office of Disability and the Health Department to the Mayor's Office of Community Development for inclusion in the City's CDBG Program in order to satisfy HUD's demand that the City reimburse the CDBG Program in the amount of \$475,000 for the improper use of grant funds at the Property.
