

1 [Modifying provisions of resolution 10, 435.]

3 **Resolution urging the San Francisco Public Utilities Commission to work with the San**
4 **Francisco Recreation and Parks Commission to modify provisions of resolution**
5 **10,435.**

7 WHEREAS, The San Francisco Public Utilities Commission (SFPUC) owns the lands
8 surrounding Lake Merced commonly known as the Lake Merced Land Tract,

9 WHEREAS, Resolution 10,435 signed and adopted by the SFPUC in 1950 has served
10 as the mechanism for management of that land tract by the San Francisco Recreation and
11 Park Department (SFRPD); and,

12 WHEREAS, The SFRPD has managed the Lake Merced Land Tract via a complex
13 accounting practice whereby monies from the SFPUC have been allocated to SFRPD for day
14 to day maintenance of the land tract; and,

15 WHEREAS, Investigations and studies about the conditions and management of Lake
16 Merced and the surrounding Lake Merced Land Tract have led the SFPUC to conclude that
17 most of the Lake Merced Land Tract should be managed following standards applied to the
18 management of an urban watershed; and,

19 WHEREAS, The SFPUC has made a commitment to manage and maintain all of the
20 watershed lands under its jurisdiction using best management practices for sustainable
21 watersheds, and has made commitments to obtain and allocate the resources necessary to
22 manage the Lake Merced Watershed; now, therefore, be it

23 RESOLVED, That the San Francisco Board of Supervisors urges San Francisco Public
24 Utilities Commission to work with the San Francisco Recreation and Parks Commission to
25 modify provisions of resolution 10, 435; and, be it

1 FURTHER RESOLVED, That the San Francisco Board of Supervisors requests a joint
2 progress report and timeline for implementation of this resolution from the SFPUC and
3 SFRPC within 90 days from the date of introduction of this resolution.
