3 **Ordinance appropriating \$4,770,707 in Ambulance Service Revenue in the Fire**  
4 **Department, de-appropriating \$84,988,592 from permanent salaries, mandatory**  
5 **fringe benefits, and programmatic projects, and appropriating \$89,759,299 to**  
6 **overtime in the Department of Emergency Management, Fire Department, San**  
7 **Francisco Public Utilities Commission, Sheriff’s Department, and Police**  
8 **Department, in order to support the Departments’ projected increases in overtime**  
9 **as required per Administrative Code Section 3.17; this Ordinance requires a two-**  
10 **thirds vote of all members of the Board of Supervisors for approval of the Fire**  
11 **Department’s appropriation of \$14,509,676, pursuant to Charter, Section 9.113(c).**

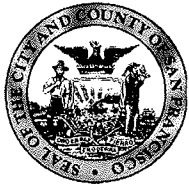
