Mountain Tunnel Improvements

Project will rehabilitate existing 18-mile-long tunnel built in 1925:

- Lining repair;
- New access adit at Priest Reservoir;
- New Flow Control Facility at Priest;
- Access road safety improvements.

- Successful implementation of first of 5 annual 60-day to 100-day shutdowns.
- Excavation of Flow Control Facility shaft to 100-foot depth and new Priest Adit access to 200-foot length.
- SRF low interest loans will save about \$100M

Three subprojects will rehabilitate 60-year-old powerhouse.

Progress and Status: Subproject A (Step-Up Transformers)

New GSU 1 transformer installed (photo) on oil containment foundation (photo); relay panels tested and commissioned; partial use in Q4.

Subproject B (Generators Rewind)

100% design for generator rewind items and 65% design for relay protection and control panels.

Subproject C (MPH Upgrades) initiated planning.







San Joaquin Pipelines (SJPL) Valve and Safe Entry Improvement

also increases pressure rating. Four separate construction contracts.
