Be it ordained by the People of the City and County of San Francisco:

Section 1. The San Francisco Police Code is hereby amended by adding Section 154, to read as follows:

SEC. 154. PROHIBITING PUBLIC NUDITY.

- (a) The Board of Supervisors finds that a person's public exposure of his or her private parts (1) invades the privacy of members of the public who are unwillingly or unexpectedly exposed to such conduct and unreasonably interferes with the rights of all persons to use and enjoy the public streets, sidewalks, street medians, parklets, plazas, public rights-of-way, transit vehicles, stations, platforms, and transit system stops, (2) creates a public safety hazard by creating distractions, obstructions, and crowds that interfere with the safety and free flow of pedestrian and vehicular traffic, and (3) discourages members of the public from visiting or living in areas where such conduct occurs. The Board of Supervisors has enacted the provisions of this Section 154 for the purpose of securing and promoting the public health, safety, and general welfare of all persons in the City and County of San Francisco.
- (ab) A person may not expose his or her genitals, perineum, or anal region on any public street, sidewalk, street median, parklet, or-plaza, or public right-of-way as defined in Section

2.4.4(t) of the Public Works Code, or in any transit vehicle, station, platform, or stop of any government operated transit system in the City and County of San Francisco.

- (bc) The provisions of this chapter shall not apply to (1) any person under the age of five years or (2) any permitted parade, fair, or festival held under a City or other government issued permit.

 Notwithstanding this exemption, all persons participating in or attending permitted parades, fairs or festivals shall comply with Section 1071.1(b)(2) of the San Francisco Police Code.
- (ed) Any person who violates this Section 154 shall be guilty of an infraction and upon conviction thereof such person shall be punished by a fine not to exceed one hundred dollars (\$100) for a first violation, and not to exceed two hundred dollars (\$200) for a second violation within twelve months of the first violation.
- (de) Upon the third or subsequent conviction under this Section 154 within twelve months of the first violation, such person shall be guilty of an infraction or a misdemeanor. The complaint charging such violation shall specify whether, in the discretion of the District Attorney, the violation is an infraction or a misdemeanor. If charged as an infraction, upon conviction, the violator shall be punished by a fine not to exceed \$500. If charged as a misdemeanor, upon conviction, the violator shall be punished by a fine not to exceed \$500 or by imprisonment in the County Jail for a period not to exceed one year or by both such fine and imprisonment.
- (ef) This Section shall not supersede or otherwise affect existing laws regulating nudity under the San Francisco Municipal Code, including but not limited to the Park Code, Police Code, and Port Code. But in the event of a conflict between this Section 154 and Police Code 1071.1(b)(2), this Section 154 shall prevail.
- (fg) A violation of this Section does not require lewd or sexually motivated conduct as required under the indecent exposure provisions of California Penal Code Section 314 or for purposes of California Penal Code Section 290(c).

(h) Severability. If any section, subsection, sentence, clause, or phrase of this

Ordinance is for any reason held to be invalid or unconstitutional by a decision of any court of
competent jurisdiction, such decision shall not affect the validity of the remaining portions of
the Ordinance. The Board of Supervisors hereby declares that it would have passed this
Ordinance and each and every section, subsection, sentence, clause, or phrase not declared
invalid or unconstitutional without regard to whether any portion of this Ordinance would be
subsequently declared invalid or unconstitutional.

Section 2. Severability. If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be invalid or unconstitutional by a decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of the Ordinance. The Board of Supervisors hereby declares that it would have passed this Ordinance and each and every section, subsection, sentence, clause, or phrase not declared invalid or unconstitutional without regard to whether any portion of this Ordinance would be subsequently declared invalid or unconstitutional.

Section 32. Effective Date; Operative Date. This ordinance shall become effective 30 days from the date of passage. The operative date of this ordinance shall be February 1, 2013 or the effective date, whichever is later.

LEGISLATIVE DIGEST

[Police Code - Prohibiting Public Nudity]

Ordinance adding Section 154 to the San Francisco Police Code, to prohibit nudity on public streets, sidewalks, street medians, parklets, plazas, and public rights-of-way, and on public transit vehicles, stations, platforms, and stops, except as part of permitted parades, fairs, and festivals.

Existing Law

Police Code Section 1071.1 (Regulating Public Nudity in Restaurants and Public Seating Areas) currently regulates the public nudity of waiters, waitresses, entertainers, and customers in restaurants and of people who sit on public benches, steps, or other public seating areas without clothing or other material as a barrier between certain of their body parts and the public seating.

Both the Park Code and the Port Code provisions regarding "disorderly conduct" prevent members of the public ages 5 and up from exposing certain body parts on Recreation and Park or Port property. (Park Code §4.01(h); Port Code §3.1(H).)

Amendments to Current Law

The proposed Ordinance would amend the Police Code to prevent any individual from exposing his or her genitals, perineum, or anal region on any public street, sidewalk, street median, parklet, plaza, and public right-of-way, or in any public transit vehicle, station, platform, or stop, except as part of permitted parades, fairs, and festivals or when the individual is under the age of five. The fine for a violation shall not exceed one \$100 for a first violation, and shall not exceed \$200 for a second violation within twelve months of the first. A third or subsequent conviction within twelve months of the first violation will be an infraction or a misdemeanor. If the District Attorney charges the violation as an infraction, upon conviction, the fine shall not exceed \$500. If charged as a misdemeanor, upon conviction, the punishment shall be a fine not to exceed \$500 or imprisonment in the County Jail for no more than one year, or both.

A violation of the proposed Ordinance would not require lewd or sexually motivated conduct as is otherwise required under California Penal Code Section 314.

Dear City Supervisor:

As a former resident and now occasional visitor to your city
I am writing to express my concerns about what effect the impending nudity ban
may have on one of my primary reasons for visiting your city; The annual Bay
to

Breakers. Below is a copy of a letter I have sent to race sponsor Zazzle and other local sponsors and merchants expressing my cause for concern.

To B2B or not to B2B? That is the question I must now ask myself. As a former resident of the Bay Area, I truly enjoy returning each year

to participate in the unique event that is the Bay to Breakers. One of the best

things about the Bay to Breakers has always been walking back along the course after the finish to enjoy the revelry and socialize with the many people dressed in creative and even risqué costumes, or even people not dressed at all. Where else but San Francisco can such a thing be found? Unfortunately it has come to my attention that this may drastically change if City Supervisor Scott Wiener gets his way and enacts a very loosely worded and draconian, city wide nudity ban.

I have been closely following this controversy over the past few weeks. Recently Mr. Wiener held what can only be described as a very undemocratic, mock hearing, in which he ignored overwhelming opposition in order to fast track his agenda. I know Mr. Wiener has said that events such as the B2B would be exempted, under his so called "Wiener law," within certain strict guidelines. However he has also made it very clear, in at least one emailed reply to a friend, that this will be a very limited exemption, and has said nothing at all to assure me that the B2B will continue to be exempted in the future. If Mr. Weiner's bill does become law, I and many friends of mine would no longer feel comfortable spending a great deal of money to travel across states, to attend what will essentially become a half-day event, or worse yet, to inadvertently face possible citations for indecency. The Wiener law

will do nothing for the B2B other than to add confusion. Costumes that are perfectly acceptable during the 7:30 to noon operation of the event could suddenly become citable offences at the sole discretion and whim of individual law enforcement officers as soon as the noon hour arrives. The text of Mr. Wiener's bill is extremely vague and completely open to interpretation as to exactly what constitutes indecent exposure once the official ending time of the

B2B expires. While the vast majority of participants are technically clothed,

great many of the costumes are extremely form fitting or even transparent enough to make the anatomy visible. Would such a costume constitute indecent exposure while walking back to my hotel or vehicle after the race? Additionally,

Mr. Weiner has stated that these temporarily permitted styles of dress will be strictly limited to the race course and immediate area only, yet does not define precisely what areas those are. Wearing an unsuitable costume while walking to or from the event, for example, is specifically disallowed and would

be considered a violation of law, yet it is unclear exactly what kinds of costumes are permitted, or if leaving the course to use a port-a-john or to patronage local merchants will also become illegal.

For this, and other similar reasons, I and many like me, feel that if the Mr. Wiener has his way, it will no longer be worthwhile to attend the Bay to Breakers. I personally would not want to travel such a distance to attend something where I may unknowingly risk costly citations simply for enjoying the many street-parties or even for simply trying to leave!

While I and others may feel that we are completely covered and in compliance with the laws of a newly conservative San Francisco, individual police officers

with ticket quotas to fill may have a different opinion. Just as the Oakland A's have decided that their city is no longer suitable, likewise SF may no longer

be suitable for the unique expression of freedom and liberty that is the B2B.

last thing San Francisco needs is a New Jerseyite like Scott Wiener, inflicting

his east coast values on a city that he clearly doesn't like and does not understand. If San Francisco does indeed turn its back on its history, heritage

and tradition, perhaps it is time to end a century of Bay to Breakers and instead start a new tradition in another Bay Area city, one that remains liberal and would not be ashamed to fully support it, rather than making mockery with vague exemptions under nebulous laws. I hope that as a sponsor, Zazzle can help persuade city Supervisors that the Wiener bill is not only unnecessary

but harmful to both the institution of the Bay to Breakers as well as the reputation of the City itself. While I am hopeful of attending the 2013 Bay to Breaks, I am fearful that I will be forced to find another city in which to spend my hard earned money.

My message to you is simple: no ban on nudity in SF. As an older gay man, I remember the days when laws were passed to restrict public space to gay men or drag queens because people were offended by us. In my hometown of Philadelphia in the early 70s, two or more gay men couldn't walk down the street at night after a certain time or we'd be stopped by the police and possibly arrested. There was actually a law against it. In the Rittenhouse Square area of town, gay men and drag queens used to congregate at night. Neighbors complained to police about us because they were offended at the sight of gay men cruising and drag queens simply because of who they were. Police would come into the park and chase us out because we were offensive to neighbors.

In the late 90s right here in SF in the Castro, neighbors and merchants opposed three shelters for homeless queer youth that I helped establish because they were offended by the thought of having these kids in their neighborhood. One mother stood up at a community meeting and said that her children would get "cooties" (I kid you not, she said that) from the homeless kids. Fortunate for us, then—Supervisors Mark Leno and Tom Ammiano did not give in to this foolishness and the shelters all opened.

Show the same courage: don't give in to the anti-nudism bigotry of those few people in the Castro who are "offended" by naked men. Keep SF the wild and wonderful place it is when we allow personal freedom to flourish.

Breakers. Below is a copy of a letter I have sent to race sponsor Zazzle and other local sponsors and merchants expressing my cause for concern.

To B2B or not to B2B? That is the question I must now ask myself. As a former resident of the Bay Area, I truly enjoy returning each year

to participate in the unique event that is the Bay to Breakers. One of the best

things about the Bay to Breakers has always been walking back along the course after the finish to enjoy the revelry and socialize with the many people dressed in creative and even risqué costumes, or even people not dressed at all. Where else but San Francisco can such a thing be found? Unfortunately it has come to my attention that this may drastically change if City Supervisor Scott Wiener gets his way and enacts a very loosely worded and draconian, city wide nudity ban.

I have been closely following this controversy over the past few weeks. Recently Mr. Wiener held what can only be described as a very undemocratic, mock hearing, in which he ignored overwhelming opposition in order to fast track his agenda. I know Mr. Wiener has said that events such as the B2B would be exempted, under his so called "Wiener law," within certain strict guidelines. However he has also made it very clear, in at least one emailed reply to a friend, that this will be a very limited exemption, and has said nothing at all to assure me that the B2B will continue to be exempted in the future. If Mr. Weiner's bill does become law, I and many friends of mine would no longer feel comfortable spending a great deal of money to travel across states, to attend what will essentially become a half-day event, or worse yet, to inadvertently face possible citations for indecency. The Wiener law

will do nothing for the B2B other than to add confusion. Costumes that are perfectly acceptable during the 7:30 to noon operation of the event could suddenly become citable offences at the sole discretion and whim of individual law enforcement officers as soon as the noon hour arrives. The text of Mr. Wiener's bill is extremely vague and completely open to interpretation as to exactly what constitutes indecent exposure once the official ending time of the

B2B expires. While the vast majority of participants are technically clothed, a

great many of the costumes are extremely form fitting or even transparent enough to make the anatomy visible. Would such a costume constitute indecent exposure while walking back to my hotel or vehicle after the race? Additionally,

Mr. Weiner has stated that these temporarily permitted styles of dress will be strictly limited to the race course and immediate area only, yet does not define precisely what areas those are. Wearing an unsuitable costume while walking to or from the event, for example, is specifically disallowed and would

be considered a violation of law, yet it is unclear exactly what kinds of costumes are permitted, or if leaving the course to use a port-a-john or to patronage local merchants will also become illegal.

For this, and other similar reasons, I and many like me, feel that if the Mr. Wiener has his way, it will no longer be worthwhile to attend the Bay to Breakers. I personally would not want to travel such a distance to attend something where I may unknowingly risk costly citations simply for enjoying the many street-parties or even for simply trying to leave!

While I and others may feel that we are completely covered and in compliance with the laws of a newly conservative San Francisco, individual police officers

with ticket quotas to fill may have a different opinion. Just as the Oakland A's have decided that their city is no longer suitable, likewise SF may no longer

be suitable for the unique expression of freedom and liberty that is the B2B.

last thing San Francisco needs is a New Jerseyite like Scott Wiener, inflicting

his east coast values on a city that he clearly doesn't like and does not understand. If San Francisco does indeed turn its back on its history,

and tradition, perhaps it is time to end a century of Bay to Breakers and instead start a new tradition in another Bay Area city, one that remains liberal and would not be ashamed to fully support it, rather than making mockery with vague exemptions under nebulous laws. I hope that as a sponsor, Zazzle can help persuade city Supervisors that the Wiener bill is not only

but harmful to both the institution of the Bay to Breakers as well as the reputation of the City itself. While I am hopeful of attending the 2013_Bay to Breaks, I am fearful that I will be forced to find another city in which to spend my hard earned money.

As your constituent, I strongly urge you to oppose legislation introduced by Supervisor Scott Wiener that would ban nudity and revealing clothing throughout the city except at a handful of special police-sanctioned events. The controversy over nudity at Jane Warner Plaza is local, not city-wide. Neither side is claiming that the nudists have harmed anyone -- the whole issue revolves around activities at one small plaza. Why should a drastic city-wide solution be used to resolve a minor local controversy? Scott Wiener is turning a problem that could be quietly solved in his own district into a media-grabbing story involving the whole city. His "solution" to the problem is like putting cyanide in the water supply to improve the taste. Legislation should be designed to efficiently solve a specific problem, without huge unpredictable side effects. Scott Wiener's proposed anti-nudity law is poorly designed, inefficient, and has huge unpredictable effects on San Francisco's reputation as a city where personal freedom is encouraged to flourish. Wiener's Law would make San Francisco into just another city where prudishness and irrational taboos are in control of social policy. The national media will be watching the outcome of this controversy in San Francisco. If the city bans nudity, the news media will have a field day with it. The story will be on every TV news program and in every newspaper. But the news media often misreport the details of the stories they carry. The story of Scott Wiener's nudity law will inevitably contain inaccuracies in some news reports and will be misunderstood by many readers. Some potential visitors to the city's big nude-friendly events will assume that these events will be spoiled or even canceled because of the new law. No amount of explaining to reporters about exemptions will prevent a certain amount of misreporting and misinterpretation. This confusion will cost San Francisco dearly in lost tourist business. About 150,000 people attended the Bay to Breakers event last year, many of them from out of town. Some of these visitors stayed for days, or even a week. They spent money on food, hotel rooms, taxis, and sightseeing. If even 1% of those attendees skip the event next year because of confusion over a new nudity law, that's a loss of 1500 people - and a loss to the city's businesses of the money they would have spent here. Attendance at the Folsom Street Fair is about 400,000. If Wiener's ban results in the loss of 1% of that number, that's a loss of 4000 people, along with the money they would have spent in San Francisco. These losses would be in the millions of dollars. Do San Francisco's supervisors really want to take the blame for recklessly damaging the city's economy?

Dear Supervisor Olague:

I am writing to you to ask you to oppose the proposed ban on public nudity. San Francisco has been a beacon of freedom for minorities for decades, and we feel that this legislation puts this freedom at risk. While some consider public nudity objectionable, this is an objection rooted in a culture that sexualizes the body. We are all born naked, but we cover it not only for warmth, but because we perceive any exposure of the body is for sexual purposes. Members of Gay Naturists International (GNI) find this notion antiquated. We celebrate our bodies, whether they are toned or flabby, young or old. For our members, San Francisco is one of the few places that honor diversity and difference, and the current rules allow for a rich dialogue about the role of the body.

We understand that there are concerns about the activities of some individuals who choose to be naked in public, but existing legislation on lewd activity can and should be enforced to address this problem.

GNI is the largest organization for gay male nudists, and organizes and sponsors social events for nudists across North America. Our organization exists <u>because</u> of the limitations placed on nudity. In order to provide opportunities for our members to socialize in the nude, many of the local events sponsored by our affiliates occur in private homes, and larger events are limited by the relatively small number of clothing-optional beaches and resorts in the U.S.

Supervisor Scott Wiener is a very shrewd and ambitious politician and let's be painfully clear here; the current public nudity debacle that he has single-handedly created is almost entirely politically driven. He undoubtedly surprised no one with his magnanimous announcement yesterday that he's removing "buttocks" from his draconian legislation. Supervisor Wiener must have known all along that his original draft would clearly upset San Francisco's significant leather community and he timed his "grand compromise" perfectly. He's undoubtedly hoping any support nudists may have from other "alternative lifestyle" groups will evaporate like the morning dew . . . just before Monday's public hearing. I hope insightful people on both sides will see through this shamefully manipulative charade.

While we're talking about this latest twist, let's look at exactly what anti-nudity folks would be getting with the new and improved "genital only" ban. If the law passes, my wife and I would be allowed to roam around the city wearing a string around our waists with a small piece of fabric hanging in front . . . just enough to safely cover our genitals. And Supervisor Wiener believes this would solve the problem of concerned Castro parents having to explain to their allegedly curious children why on earth someone might actually prefer the freedom of not wearing clothes on a warm afternoon?! Kids are very inquisitive and as a lifelong nudist, I can guarantee you such a minimalist outfit would attract FAR more attention than total nudity, yet ludicrous and unnecessary laws like this one create just such a paradox. And whether or not opponents choose to believe it, the vast majority of urban nudists are NOT attention-seeking exhibitionists. Wouldn't it be healthier to just teach our children up front that the human body is not something to be ashamed of? Things like graphic window displays at the many sex shops, aggressive panhandlers, homeless people urinating on the sidewalks, drug addicts wandering aimlessly, lurid posters for sex shows plastered over all of the power poles, etc. As much as I personally love the flavor of the Castro (and financially support it feverishly when I'm there), it has never felt like "Mayberry" to me. I think urban children are a lot more insightful than some parents give them credit for being, and respected studies have consistently shown that nudity (in the absence of lewdness) does absolutely no harm to them.

On a separate subject, when I hear people say that my right to be nude is trumped by their right to not be offended, it makes me cringe. Society gives us absolutely no "right" to not be offended. There are many people who I might find disturbing to look at (and a good number of them seem to congregate CLOTHED at Jane Warner Plaza) but I would never dream of seeking legislation to ban them from the streets. That's not what a free society is about and NO OTHER CITY exemplifies that freedom like San Francisco. Rights are an emotional issue. It's easy to dismiss the urban nudists by minimizing their plight as simply being about an "apparel choice" but that freedom matters a great deal to them and the right to choose that option has in fact been granted to them by the city for many years. The bottom line is that Supervisor Wiener's ban would take that existing right away from them and I dare say they see that as being far more important than their opponents are willing to recognize.

The saddest part of this colossal waste of city resources is that the entire problem could have been easily resolved with two quick actions. Simply designate the seating area at Jane Warner Plaza as "nudity prohibited" and enact a ban on displaying so-called "cock rings" in public. Supervisor Wiener said all along that the catalyst for this decidedly local controversy was a perceived congestion at the Plaza so why not just ban nudity there, instead of all over the entire city? He even stated that he had no problem with nudists just innocuously strolling around so why take that right away from them? And there are already very clear laws against lewd behavior in public. If we need to add genital jewelry to the list, so be it. But do we really want to throw the baby out with the bath water? A city-wide ban on an activity that has become integral to San Francisco's make-up (and one which brings many visitors . . . and their vacation money) is unconscionable and will only serve to diminish the city's enviable reputation as an undisputed bastion of tolerance.

Subject: Proposed anti-nudity legislation

We are pleased that you, unlike Supervisor Wiener, probably do not have direct political influence from the Castro and will hopefully act responsibly for the city of San Francisco, its nudist citizens, and responsible nudist visitors. We are anxious to help.

We are a non-political, non-funded group which is part of the greater San Francisco "Urban Nudist" movement with objectives of providing public awareness, welcoming visitors to the Castro, helping to keep the area clean, and providing security similar to the clothed volunteers who provide a similar service there. Please don't think that a small group of serious enthusiasts cannot be effective. Similar groups have shown that with cooperation, peaceful outcomes can be obtained to the satisfaction of all parties.

We are very sensitive to our neighbors and have for some time now, on a daily basis, used actual police reports as well as contact with citizens as a means of judging public acceptance. Items noted as "FACT" below come from these reports. A summary of these is also attached. Please study all of them. It is apparent that Supervisor Wiener has not used such information as he continues to erroneously claim that the majority of Castro residents oppose public nudity. He cannot substantiate this with actual documented evidence and makes vague references such as "I've heard businesses have suffered" or "People have told me their neighbors are unhappy".

Mr. Weiner himself largely brought on this issue and in so doing created a major problem out of a minor issue! Nudists in the Castro and the rest of the city had been coexisting with the public for many years. We accept that the situation at Jane Warner Plaza could be improved and will close with recommendations for it.

Supervisor Wiener's statement that he had hoped the situation "would self-correct but it has not" is false. FACT: Actual complaints are now are at a level at or below that which existed before the Wiener-inspired increase occurred. He has said many times that he is not opposed to nudists strolling and that his problem is only with the Plaza. He has also responded directly to some of our members stating this position even after publishing his sweeping anti-nudity legislation. Supervisor Wiener went as far as to tell these same members that he'd be willing to "wait and see" if things could improve with self-policing by our ranks . . . four days before submitting his city-wide nudity ban proposal! He has done absolutely nothing to constructively address the situation at the Plaza and, in fact, has only stirred up trouble and encouraged large protests which have made matters even worse!

We have heard Supervisor Wiener speak before and while he seemed lucid, his proposed legislation shows extreme insensitivity and poor planning as well as irrational judgment. After the last "Nude-In" demonstration, he made the following statement:

"I completely support their right to protest in the nude. I don't agree with the statements, but we are an open and diverse neighborhood, and we need to embrace everyone."

The "statements" he was referring to were our observations that he was proposing a city-wide ban to solve a local issue. And claiming that he believes "we need to embrace everyone" while attempting to take away the rights of a legitimate group of citizens is absurd! We should indeed embrace everyone,

including nudists. His legislation does exactly the opposite and is specifically designed to cater to a relatively small but very vocal and powerful group of his own constituents.

Supervisor Wiener has proposed nothing whatsoever that could help to alleviate the current controversy at the Plaza and has steadfastly refused to listen to responsible nudist leaders who, unlike him, are looking for a "win-win" compromise. While it would violate rights previously granted to nudist citizens (and is not necessarily the best option), he could have solved the decidedly local Plaza dilemma by simply proposing the following restriction:

No nude sitting, standing, or gathering in Jane Warner Plaza

The mere idea that the proper solution to a local issue at one gathering space is to legislate a city-wide ban of an innocuous practice that has become integral to San Francisco's character is unconscionable and makes no sense whatsoever. This ban would be a black eye for a city that has spent decades building an enviable reputation for tolerance of alternative lifestyles of ALL kinds!

Supervisor Wiener's claim that things have not worked out on their own is false based on accurate police data. In the two months since the last "Nude-In" there has been only one police complaint and it was three blocks from the Plaza. Over the years, public nudity has become increasingly common in several areas of the city, including (but not necessarily limited to) the Haight, SOMA, Downtown, Fisherman's Wharf, the Embarcadero, neighborhoods adjacent to Golden Gate Park, and of course the Castro and areas west and south of it.

FACT: On the day of last year's "Nude-In" there were no complaints in the Castro area where we monitor. None! And this year, there was only one.

Other factors you should consider before we move on to rational legislation options.

- 1. Nude-Ins: These unlicensed events, held yearly at the Plaza, have drawn in many nudists. The city, and in particular Councilman Wiener, knew about them yet did nothing at all to make formal recommendations that they be held elsewhere, therefore letting them add to the tensions in the Castro. We are certainly not opposed to these events but they have indeed taken over the small, tight quarters of the Plaza. We suggest such gatherings might become a formal yearly event in an area that can better accommodate them. Such gatherings are very similar to the annual World Naked Bike Ride which is held in large metropolitan areas all over the world, even conservative cities like Philadelphia.
- **2. False claims:** One glaring example repeatedly made by the minority opposition in the Castro (influential political supporters?) is that nudity is the biggest problem there. Not So! Please see attached typical daily crime summary. This example has one nude to four homeless complaints. The reports typically show the ratio to be zero to six or more.
- **3. Public acceptance and comments to nudists from passersby:** Personal complaints are nil. By far the most complaints and even physical abuse directed toward people walking nude come from the homeless in the Tenderloin. The Castro is no exception as far as homeless and panhandlers are concerned. Recent verbal abuse has come from a guy living on 15th at Sanchez behind the restaurant, sleeping there on a pile of cardboard, and another in the Pink Triangle Park where physical contact was involved. Is Mr. Wiener catering to the homeless and panhandlers of the city?

San Francisco's enviable reputation as a leader in supporting freedom for all is at risk! Ours is one of the most vibrant and diverse urban areas in the world but reckless legislation like this could turn us into "just another big city". Supervisor Wiener's proposal would be a backward step for San Francisco, eliminating individual rights previously granted, and all for what appears to be his own political gain. Time to start over! Mr. Wiener has bigger fish to fry. Please see attached sample of crime in the Upper Market section of the city.

Complaints primarily come from areas where nudists and major pedestrian concentrations exist such as Jane Warner Plaza.

"Nudists are spotlighted in the sun with not even a partial visual barrier. They also often sit on the plaza very close to that intersection which is not the best situation."

Let's use this example to demonstrate how cooperation will help. A proposal that would be fair to those who have practiced nudism in the past and that would also respect those looking for some moderation involves the placing of a barrier similar to the concrete structures already there, or the rearrangement of some of the existing planters. This would form an area most distant from 17th and Castro (near Market Street on the side adjacent to Castro). A decorative chain separating the nudist area has also been suggested. Such a barrier would serve to give both sight and seating restriction and would better allow nudists the ability to self-regulate. Should this solution not work, the remaining area could be posted with signs simply stating "no nudist seating in this area". Different colored chairs, appropriately placed, was another suggestion.

Proposal

Amend the existing law which acknowledges nudism in the city as follows:

- 1. Nudity is banned on public transportation and immediately associated boarding and debarking areas city wide.
- 2. Nudist demonstrations and celebrations shall be licensed just like other gatherings.
- 3. A means to define and limit seating for nudists at Jane Warner Plaza shall be implemented that would locate them at the corner closest to Castro and Market.
- 4. From dawn to dusk, nudists strolling shall limit their group sizes to no more than four. Extended standing or obvious posing is prohibited (though casual posing for requested tourist photographs is acceptable). Body jewelry or outlandish hats or other wear that clearly serve to draw attention are prohibited. Financial gain from nudity is prohibited.

Let's not turn San Francisco into a place folks will choose not to visit with rash, poorly thought out legislation. Better that we find a way for San Francisco to remain a bastion of freedom and to BE San Francisco!

Dear Supervisors,

I reside in the state of New York. I travel to San Francisco two times a year for vacation, and, as such, believe I offer a valuable perspective on Supervisor Wiener's public nudity legislation. If the legislation passes, I will surely cancel my future travel plans to San Francisco. I believe the "blanket exemption" is too nebulous and in dire need of substantive and definitive guidelines to prevent possible law enforcement abuse at such popular events as the Bay to Breakers and Gay Pride.

I am in agreement with Supervisor Wiener concerning the existence of a problem in Jane Warner Plaza. However, this problem is local in nature, requiring a local solution rather than a city-wide ban. Supervisor Wiener has stated that a city-wide ban on nudity is the only solution, but it would be impossible to know that for certain. Accordingly, incremental legislative action would seem more appropriate than the uniform and indiscriminate legislation currently under consideration.

By passing a city-wide ban on nudity, you risk undermining the unique aspects of some of San Francisco's most popular and cherished events. The intent of the "blanket exemption" is to preserve those unique aspects, but it is unlikely to achieve that result unless prudent guidelines are added. For example, under the current legislation, once the Bay to Breakers race officially ends, the "blanket exemption" would expire as well. But the official end of the race occurs much earlier than the actual end and thus would allow an overzealous police officer to fine nudists. Moreover, the "blanket exemption" does not adequately address issues of jurisdiction and thus leaves too much discretion for law enforcement, while promoting uncertainty and confusion over the new restrictions.

If you do pass a city-wide ban on nudity, I would hope that you add additional content and safeguards to the "blanket exemption" to ensure that nudity will truly be preserved at these unique and celebrated events.

As a resident of Minnesota, with many relatives in the Bay Area, I look forward to my visits to San Francisco.

Typically I travel several times a year. Each visit, I spend between \$1000 and \$2000 within the City of San Francisco.

I look forward to being in, and enjoying, San Francisco because it has long been, and remains, a city open to difference and diversity. That's what makes it exciting, and vibrant – and a city head and shoulders above most in this country.

I'm writing because there is legislation proposed that would ban nudity. If passed, it would be a sorry signal for the city to send to its residents and its visitors.

Such legislation signals intolerance of personal difference and personal expression. Many will wonder "who's next?" If the city can single out one group for repression, how many more will it target?

If this targeted group were somehow contributing to public disorder, it might be worth considering legislation of some sort. But I have been following the debates over this matter, and it is clear that there is already legislation at hand that addresses any opportunity for public disorder.

Behind this ordnance are people who, legitimately, have an aesthetic preference for clothing over nudity. But it can hardly be the city's duty to enforce aesthetic preference, particularly with respect to the human body. If he persisted, I would call the police and ask them to enforce laws that are already in place to handle people who are doing uncool or even dangerous/harmful things.

I ask you now: WHY AREN'T THOSE EXISTING LAWS ENOUGH? How is it useful or a good use of time or money to enact more laws that will only punish a larger number of people for no benefit to society whatsoever?

Adding more laws—instead of using the laws already in place to manage a few bad apples who are

causing meaningful problems—will have a handful of chilling effects:

- 1) Banning nudity will punish a much larger number of people who aren't doing anything wrong. In the Mid October Bay Area Reporter Scott Wiener said "My intent is not to interfere with people's ability to wear chaps," Wiener said last week. "I don't see any chance that the police will stop someone on their way to the Powerhouse." It is dangerous to enact laws to prohibit something but which you do not intend to enforce, and saying so is irresponsible, embarrassing, and shows disregard for governance and our legal system, let alone how wrong headed this entire thing is.
- 2) Banning nudity damages the "branding" of our city. San Francisco has long fought the influx of big chains. We have lead the way on responsible bicycle transit integration. We have always strived—perhaps imperfectly—to socioeconomic harmony in a city of extremes. There are plenty of cities in flyover states that cater to Applebees, Home Depot, and tight lipped unhappy body shame. Let them be a shining counterpoint to our thriving city.
- 3) Banning nudity codifies that the human body is shameful. It is not. There's plenty of that message to go around everywhere else. Why bother repeating it here?

I love our city. Please let it stay unique!

Subject: Nudity Ordinance

I'm sending this to you in reference to the proposed city ordinance that would ban non-sexual nudity city wide, instead of in the city park.

In what I've read, this ordinance would permit nudity in certain events such as permitted fairs, parades, festivals, etc. If this is going to be allowed during these events, I see no reason why non-sexual nudity should not be allowed city wide, except where currently prohibited by any city or state codes.

I do see in 2011 that Sup Wiener did introduce an ordinance requiring that any nude person sitting on public chairs or benches, place a covering between themselves and what they are sitting on. This is nothing out of the ordinary, as anyone attending a nudist resort are required to do the same when sitting in a chair.

San Francisco is a city of diversity and I think that it should stay that way. In Texas, the City of Austin allows females to go topless, which I've seen a few, if they desire, but not full nudity. While Austin is a city of diversity and accepts a broad range of individuality, your city goes well beyond what Austin does.

I'm aware that many people come to your city to attend some of the festivals and events because nudity is allowed, especially events such as; bay to breakers & Folsom Street Fair. While I've not got to attend these, I've known people that have, and they have enjoyed themselves because of this freedom.

In reading some additional information, surveys that have been done show that about 68% of your citizens are not offended by non-sexual or social nudity. I should point out that there is a BIG difference between non-sexual nudity or social nudity and sexual nudity and lewd behavior. Nudist are offended by this type of behavior, because it gives us social nudist a bad name. This type of behavior is not even allowed at nudist resorts, at least those that are members of AANR or TNS.

With the diversity in your city, any non-sexual nudity being allowed and everyone seeing it daily, I would think that those that are "offended" would have said something sooner, especially when additions were made to this ordinance in the past.

As I've mentioned, non-sexual nudity or social nudist is just that, social, a choice made by the person to express their desires to be free in public or in private, such as home nudists. Social nudist don't want people to confuse social/non-sexual with sexual nudity or lewd behavior. As stated above, nudist have no tolerance for lewd behavior and will report this to police.

It seems that this issue is only limited to one certain area in your city and that is the Castro/Market area and Jane Warren Plaza. So, concentrate on this area. If seating is an issue, maybe install additional seating. I don't see where one area would require a city wide change, if no other areas are complaining. As pointed out, an addition was made to address one issue, so just address something for this one area.

I'm not aware of many cities that allow full non-sexual nudity in public - this is what makes your city unique, don't change that. Don't restrict someones right to free speech and expression just by changing non-sexual nudity to certain events in your city.

While I'm in Texas, and have been to California in the past, I've not been to your city, but hope to one day, and as a social nudist, I'd like to be able to express this freedom in your city, if I choose to do so.

As I stated, there are not that many cities that are as diverse as yours and I would hate to see that diversity go away. As the slogan for Austin is "Keep Austin Weird", I say "Keep San Fran Diverse."

I hope that your board will NOT make any restrictions to non-sexual nudity in your city.

Why No City Ordinance is Needed to Ban Public Nudity In San Francisco

While other cities fret about underfunded pension liabilities, here in San Francisco the latest keruffle is over the supposed "

problem" of nudists in public spaces.

Of course, this being San Francisco, the measure is being pushed by the unfortunately-named Supervisor Scott Weiner, whose main

target (based on published reports) seems to be the supposed practice of some nudists to wear "cockrings" or other devices to draw attention to their genitalia.

Lost in the debate are three fundamental (at least to a criminal defense attorney like me) questions. First, is the conduct targeted by the proposed ordinance a protected activity? Second, assuming the government can restrict the behavior, are extant State laws sufficient? Third, has state legislation already preempted the field of regulation of nudity in public spaces?

With regard to the first question, the general trend by courts in California seems to be not to grant First Amendment protection to public or private nudity unless the nudity is accompanied by or part of" 'some mode of expression which itself is entitled to first amendment protection.' "Elysium Institute, Inc. v. County of Los Angeles 232 Cal. App.3d 408, 424 283 Cal. Rptr. 688 (2nd Dist. 1991)[internal citations ommitted].

Of course, this raises as many questions as it answers-and it's almost an invitation to anyone who wants to go sky-clad to chant political slogans or carry a sign when they do so. What about a naked man with an #occupy cockring?

It may, however, explain why Supervisor Weiner says wants to exempt events like the

Folsom Street Fair and presumably, though he didn't say so explicitly, the Dyke March and the Trans March from the proposed ordinance. Simply put, he's not doing it out of kindness-those events, particularly the Dyke and Trans marches, are clearly political speech subject to First Amendment protections.

With regard to the second question, Penal Code Section 314(1) provides "Every person who willfully and lewdly...1. Exposes his person, or the private parts thereof, in any public place, or in any place where there are present other persons to be offended or annoyed thereby...is guilty of a misdemeanor" (Emphasis added).

Of course, this begs the question "What does 'willfully and lewdly' mean for the purpose of the statute? Fortunately, the California Supreme Court settled this question over 40 years ago when it decided In re Smith, 7 Cal.3d 362, 497 P.2d 807 (1972).

In Smith the Court found a man who was arrested for indecent exposure under PC 314(1) was entitled to habeas corpus relief because "The necessary proof of sexual motivation was not and could not have been made in the case at bar. It is settled that mere nudity does not constitute a form of sexual 'activity."" (J.

Mosk). Instead, the People would have to establish something more, such as "additional conduct intentionally directing attention to [the defendant's] genitals for sexual purposes" if it wanted to convict Mr. Smith of violating PC 314(1).

Similarly, a juvenile who "mooned" (i.e. exposed his buttocks) to traffic for reasons of adolescent jackassery could also not be found delinquent, since he lacked the lewd intent required by the statute (although he absolutely had the intent to annoy people) See In re Dallas W. 85 Cal.App.4th 937, 102 Cal.Rptr.2d 493 (2nd Dist. 2000).

Going back to the cockring "problem", since the purpose of a cockring is to draw attention to the wearer's genitals, wearing one in public while nude would appear to make one subject to arrest for violating PC 314(1) based on the plain language of the **Smith** case. Thus, existing state law is more than sufficient to deter the supposed problem to be remedied and the ordinance is unecessary.

What about the final question—whether or not the State has preempted this area of regulation? Unfortunately, here things get murky. While a 1975 case out of the Second District upheld a Los Angeles ordinance banning public nudity in parks (on the somewhat tortured ground that the ordinance did not purport to ban *all* nudity across the City's public spaces, but only regulate it as a time/place/manner restriction) see Eckl v. Davis 51 Cal.App.3d 831, 124 Cal.Rptr. 685 (2nd Dist. 1975) and held that the L.A. ordinance was not preempted by PC 314(1), it is unclear how modern courts would treat a similar issue today. Since Supervisor Weiner aims to ban nudity on public sidewalks as well as parks and beaches, the proposed ordinance has a far wider ambit than the measure challenged in Eckl and so the holding in that case is much less helpful to his case than it could be.

The bottom line is that—as with so many other public policy issues—what's needed is not additional laws, but enforcement of *existing* laws. That would solve the "problem" of the nudists with cockrings, to the extent it's not anecdoctal and actually exists. With regard to the wider issue of those who object to nude people in public, there's an easy remedy which costs no public money, requires no court time and consumes no scarce jail space: look away.

Dear Mayor Lee and Member of the Board of Supervisors:

With regard to the proposed ban on nudity, I hope you'll consider the broader picture: Such a ban is ill advised and will, in my opinion, have negative repercussions for the City for many decades to come.

People flee small towns and communities – narrow minded places where conservative, "mainstream" values dominate - and seek refuge and acceptance in San Francisco. Indeed, the City's reputation, both nationally and internationally, as a groundbreaking leader in gay rights, in multiculturalism, and in artistic, political, and technological innovation is legendary.

It is that intangible quality to San Francisco that gives people the courage to try new things, to innovate, to brainstorm, and to be authentic. It is through thousands of individuals, free to unleash the full potential of human creativity, in ways not yet imagined, that the most important advancements have been discovered and developed. That freedom is why the United States thrived, while command-andcontrol countries languished in the last century.

Will an urban nudist be responsible for the next Ipad? Probably not. But the environment that encourages uniqueness over conformity, that nurtures experimentation and odd connections, probably will. And I'd hate to see San Francisco lose that unique edge.

San Francisco needs thinkers – unique individuals willing to openly question tradition and custom, people willing to examine dominant social norms and their unintended and unrecognized oppressions. Supervisor Wiener's cynical law to ban public nudity is designed to directly pander to the type of people he wishes to attract to the City mainstream, wealthy individuals who can drive up rental costs and patronize expensive restaurants and shops in the neighborhood. I think that's a dangerous direction for a City like San Francisco. We're not Los Angeles, with a thriving entertainment industry. We're not New York, a center of finance. We're an innovative, quirky little town that has attracted some of the best and brightest from around the world. Lose that, and all we have is tourism, and that's a fickle industry to rely on.

Our laws should be designed to attract the thinkers, the skeptics and the rebels, not to drive them away. Granted, we don't want to be a magnet for the crazies or the dangerous, who are admittedly sometimes attracted to tolerant areas with a reputation for freedom, but there are already clear laws on the books that strictly limit lewd and dangerous behavior, and those laws should be aggressively enforced. If this City follows Wiener's lead, it will be comprised of people who migrate here only for the high wages and the extremely poor (dependent on social support), and it will lose its core. While I'm a liberal, I've seen the impact of high taxes and burdensome regulations on businesses, and how it has driven them out of the area. Take the unique appeal of the area out of the equation and it's not difficult to predict that businesses will leave the area for friendlier regulatory environments, jobs will leave - taking the high income earners with them - leaving San Francisco a shell of its former self, perhaps another Oakland.

Naturally, society needs laws to maintain order and to promote safety. But the State of California itself has already determined that it's not necessary to make simple nudity illegal. Nudity can be artistic, politically expressive, or simply a rejection of the notion that a person has to have expensive clothes or a fit, thin body in order to have self respect or be a valid human being. Nor does simple nudity harm

children. Every child has seen his/her own genitals by the time they're able to walk; in this country, we're not horrified at the sight of an uncovered face, nor is there any reason to be horrified at the sight of another human being's natural body. Nudists are not child molesters (indeed, child molesters usually try to blend into their communities, acting as "normal" and "mainstream" as possible to elicit as much trust as possible, enabling them to place themselves in positions with easy, legitimate access to children – hardly the profile of a public nudist). Children should be taught the difference between nudity and inappropriate touching and to report such touching immediately. It is not fair and totally inaccurate to conflate nudists with child molesters.

It would be a mistake for a city of San Francisco's caliber to impose an unnecessary law like the one proposed by Supervisor Wiener. This unfortunate law has garnered national media attention and, if enacted, would send a chilling message to the rest of the country, including to that isolated young person in middle town America who might have once considered San Francisco as a new home, a home where it was safe to be a little different and unique, and instead send the message that they might as well go to Houston or Chicago or Atlanta, where it's cheaper to live, jobs are available, and people are as accepting as in San Francisco.

I've lived in San Francisco since 1994, and I spend a great deal of time in The City, and particularly in the Castro neighborhood.

I'd like to register my opposition to the proposed new legislation banning nudity. I believe in people's right to free expression, and I think that our society's discomfort with the nude human form, and with sexuality, is unhealthy. Nude people on the street do no actual harm to anyone, and any laws proscribing nudity will tend to overreach, to be arbitrary and difficult to enforce, to be subject to interpretation and abuse, and to infringe on the freedom of expression in that very BASTION of free speech, the public square. The slippery slope arguments also hold water in this instance, because who is to determine what is, and what is not so "obscene" or "objectionable" as to be criminal? The majority? 50% plus one? On which day?

San Francisco has a colorful history, and we have made room for LOTS of different sorts of personal expression here — much of which has been found to be "objectionable" or "obscene" to whole swaths of normative observers. But by doing so, we have MADE history, as well.

We must resist the fear-based, conservative forces that are at work weakening the roots of our democratic society. Personal freedom of expression is a critical part of democracy and it works to promote and protect civil rights of many stripes.

Dear Mr. Evans and Ms. Wong:

As a local criminal defense attorney, I wanted to submit my comments to you regarding the proposed ban on public nudity ahead of the committee hearing on November 5, 2012.

The proposed ban is both unecessary and, in all likelihood, unconstitutional. Over forty years ago in In re Smith, 7 Cal.3d 362, 497 P.2d 807 (1972), the California Supreme Court held that "It is settled that mere nudity does not constitute a form of sexual 'activity.'" Instead, in order to secure a conviction for indecent exposure, the People in Smith had to show "additional conduct intentionally directing attention to [the defendant's] genitals for sexual purposes."

Similarly, a juvenile who "mooned" (i.e. exposed his buttocks) to traffic for reasons of adolescent stupidity could also not be found delinquent, since he lacked the lewd intent required by the statute (although he absolutely had the intent to annoy people) See In re Dallas W. 85 Cal.App.4th 937, 102 Cal.Rptr.2d 493 (2nd Dist. 2000).

To the extent that the ordinance seeks to ban the public display of devices intended to draw attention to male gentalia, such as "cock rings", it is unecessary. All the SFPD needs to do to remedy the conduct is issue citations for Penal Code 314(1), since the wearer of the ring would clearly be attempting to draw attention to their genitalia as proscribed by Smith.

More troublingly, a blanket ban on public nudity is likely to face constitutional challenges. Although a 1975 case out of the Second District upheld a Los Angeles ban on nude sunbathing in parks (Eckl v. Davis 51 Cal.App.3d 831, 124 Cal.Rptr. 685 (2nd Dist. 1975) as a time/place/manner restriction, even the Los Angeles authorities were not attempting to ban nudity across *all* public areas of the City, as I understand the proposed ordinance seeks to do (subject to exceptions not relevant for purposes of this discussion). While nudity is frequently seen to be "conduct" rather than "speech", it would take little effort for nudists to insert political content in their nudity. I doubt the SFPD and the District Attorney want to separate citations from nudists who claim to to be naked because they are #occupy members from those who just want a full body tan.

If I can be of further assistance I would be happy to expand on these remarks. Thank you for the opportunity to be heard on this issue and to assist the City as it considers this important issue.

My name is Peter Sferra and I've been a practicing nudist for my entire adult life (I'm now 57). In addition to enjoying this lifestyle in a great many traditional nudist/naturist venues such as clubs, resorts, and designated beaches, I've been able to explore somewhat more "unconventional" options thanks to living in such a tolerant area of the country. I believe that nudity is not something to be ashamed of and I raised two daughters within a community where body-acceptance was encouraged. I'm pleased to report that they're now very happy, productive, and emotionally healthy adults. I wanted to share my thoughts with you on the subject of public nudity in San Francisco in the hopes that my comments might help to guide any decisions you happen to make with regards to potential legislation that would limit or even eliminate its legal status in the city.

All too often, the street nudists are incorrectly characterized in the media as being a small group of insensitive and eccentric gay exhibitionists who have a misguided sense of entitlement and nothing could be further from the truth. We come from all walks of life and represent a very diverse population. I'm a Silicon Valley professional and work in the aerospace industry as an illustrator and technical writer. Just a relatively "normal" fellow who happens to enjoy being naked in the warm sun. My wife Laura works as a housekeeper for a wealthy couple in San Jose, where we live.

Public nudity has been an integral part of San Francisco's unique make-up for quite some time now and it's one of the many things that bring people to the city, not just at wild street festivals and crazy races but on normal days as well. It seems pretty clear that there's a huge tourist draw with the street nudists and this is obviously a very good thing for commerce. The nude-friendliness also draws in folks like Laura and me who not only want to experience the unique freedom but who also feel strongly about supporting the many small businesses up there. Every time we come to San Francisco for one of our nude adventures we buy lunch before and dinner afterwards (clothed, of course! :-). We also make sure to take the time to support local businesses by shopping for things that we could just as easily purchase in our home town. We love San Francisco as much as any resident and we want to do what we can to help it thrive.

Nudity is an integral part of a good many large annual events in San Francisco as well as a number of smaller gatherings. I've participated in the Bay to Breakers twelve times and have always delighted in the acceptance and even encouragement that the public showed the ever increasing number of nudists. This past May, Laura and I encountered a surprising number of young people along the racecourse who took the time to say hello and thank us for being "the kind of folks that help make the city unique and special". That felt really good and it gave me hope that my long-time dream of nudists and the clothed masses freely sharing urban space might really be starting to happen in San Francisco. We took the adventure a step further this year by choosing not to dress after the race and even strolled over to the Haight for some free-spirited window shopping. We were naked for eight straight hours that day and did not encounter a single negative reaction. As a matter of fact, we had a good number of friendly people, both locals and tourists alike, approach and engage us. I even asked permission from a few business owners to take photos of Laura "shopping" in their stores and they all happily agreed. Polls have consistently shown that the majority of San Francisco residents support the legal status of simple nudity and this speaks volumes to their open-minded, tolerant nature.

Laura and I had so much fun that we returned to the city in late July for the "Up Your Alley" fair. In addition to attending the actual event on Sunday, we also visited the Castro neighborhood on Saturday just to hang out and roam around. Once again, we spent significant time strolling around naked and didn't have a single negative encounter, not from people on the street nor from shop owners. While I only actually went inside Hot Cookie on this visit, I chatted with a few other businessmen and they were all too happy to have nudists around because it brought them curious tourists who were ready to spend their money. We relaxed in Jane Warner Plaza with a few fellow nudists and quite a number of clothed folks. What struck me most was how "normal" it felt and how at ease everyone was. There was no feeling at all of us being "freaks" and everyone appeared to be enjoying the warm afternoon. I had the overwhelming sense that this was a genuine social "win-win" situation that set San Francisco apart from any other large American city.

I never take this gift for granted and am well aware that an anti-nudity ordinance could be passed at any time. With that said, my hope is that the horse is too far out of the barn at this point and that the best strategy for San Francisco is to continue setting the bar for tolerance and to remain a benchmark for other progressive thinking cities. Playing devil's advocate, I realize there are those who will abuse this privilege and cross the line from mere nudity to sexually suggestive behavior. To that issue, I say why not deal with the violators? The law is pretty clear. Nudity in and of itself is not obscene so why not create an environment where a responsible couple like Laura and I can freely take a pleasant naked stroll and not have to worry about being stopped by police. Why not focus any enforcement energy on those who choose to perform lewd acts, something that has always been against the law.

Supervisor Scott Wiener has been very vocal about proposing heavy-handed legislation with a sweeping city-wide ban on nudity in an effort to appease a relatively small group of his own constituents who are upset about nudists using Jane Warner Plaza. Rather than working toward a compromise that would benefit everyone, he seems to believe the best approach to his decidedly local issue is a city-wide eradication of those who are perceived to be making waves with a very vocal minority. As you well know, expanding social boundaries never comes without its detractors. I have no doubt that there are folks up in the city who are not happy about nudists roaming around but my gut feeling is that there are far more who either support the freedom afforded to this alternative lifestyle or who really don't care one way or another. There are many things that help to make San Francisco one of the most amazing and wonderful cities in the world but clearly unrivaled tolerance and a celebration of diversity rank at near the top of the list.

I really do respect the sometimes difficult position your job places you in and I'd be most happy to continue the dialogue with you at any time and. Thanks so much for listening!

Supervisor Scott Wiener said that he had hoped the public nudity phenomenon would "run its course", dismissing enthusiasts as if they were simply freaks participating in some kooky fad. Instead it has grown significantly. He has repeatedly tried to characterize those who happen to enjoy the freedom of not wearing clothes on a warm afternoon as being a small group of selfish exhibitionists and nothing could be further from the truth, on any count. He went as far as to say folks like my wife Laura and me, who happen to live in San Jose, are "out-of-towners" who have undermined his neighborhood. Never mind that we feverishly support the community when we're here, not only buying lunch and dinner on every visit, but also shopping for things we could just as easily purchase in our own home town. Or that the presence of nudists draws in many curious and enthusiastic tourists from all over the world. Tourists who see the acceptance of public nudity as a positive thing and who are all too happy to give local businesses their vacation money.

Laura and I show great respect for those who share the streets with us and have received only one negative comment on our many nude strolls. One young woman actually thanked us for being "the kind of people who help make San Francisco unique and special" and another woman with two young children smiled as she passed us and said "Beautiful day for a walk!" Not surprisingly, that kind of encounter made us feel pretty good. I don't believe for one minute that nudists have "taken over" Jane Warner Plaza or that the majority of Castro residents are upset by their presence, but if we agree that this issue is the driver behind Supervisor Wiener's actions, why have no local solutions been examined for this neighborhood-level "problem". A city-wide ban on an innocuous activity that has become an integral part of the San Francisco scene seems disproportionately draconian and will only serve to diminish the city's enviable reputation as a benchmark for tolerance of alternative lifestyles.

Any expansion of social boundaries will have its detractors and like a lot of other controversial topics, public nudity will always ruffle some feathers. But for the record, a recently commissioned scientific poll (performed by a highly respected national organization) showed that over 63 percent of San Francisco residents are not offended by it. In fact, 46 percent of those polled strongly disagreed when asked if public nudity offends them and I can't help but believe this should be a powerful message to those who would attempt to determine who is "acceptable" on the streets and more importantly, who is not.

You have already received a couple of messages from me regarding the proposed city-wide ban on public nudity and I'm hoping I've expressed my feelings clearly.

What I wanted to do was follow up with you because it's becoming apparent that your votes will be of paramount importance to the efforts to preserve this unique aspect of San Francisco's make-up. Let me say up front that I would never presume to try to sway you or anyone else away from anything that you genuinely believe in. My only intent in writing today is to ask you to seriously consider everything that's at stake and to try to listen to as many folks as possible (via phone, email, letter, even in-person meetings) before making a decision that could have significant ramifications not just on "urban nudists" but on a great deal more. Once closed, I doubt that this door could be re-opened anytime soon.

My understanding is that the scheduled November 5th hearing is an opportunity for a subcommittee of the Board of Supervisors to listen to public opinion and act accordingly. This <u>could</u> include sidelining the legislation altogether but the odds of that are probably not good. Ultimately, it will likely come to a full vote and I hope you will consider a number of things when making your decision. Nudists have significant public support, not only from a number of San Francisco's other alternative lifestyle groups but from a great many "ordinary" residents who have nothing at all to personally gain from the bill's defeat. They simply do not believe San Francisco should be in the business of passing laws that unnecessarily restrict the rights of people who may be "different" from the mainstream public. Like me, they also see this as a neighborhood issue that can be solved rather easily without the use of sweeping all-city legislation. I have seen this increasing public support at the rallies that have taken place recently as well as out on the streets when my wife Laura and I were strolling nude. I've also been pleased to see recent media articles of the kind linked below where a young <u>non-nudist</u> San Francisco mother airs her feelings about basic freedoms. Though there are undoubtedly folks who support Supervisor Wiener's proposed ban, I firmly believe the majority of residents support the rights of nudists. If I didn't believe that, I would have nothing at all to do with the efforts to defeat this legislation, and I most

certainly would not have allowed my full name (or that of my wife) to be published multiple times in the media. I never hide behind on-line IDs or nicknames when posting thoughtful comments to articles and opinion pieces and am happy to provide my legitimate full contact information with any correspondence. I believe in this cause with all of my heart and am quite certain that my like-minded friends feel the same way.

The vast majority of "urban nudists" are responsible citizens who are interested in building bridges and they want to be perceived as positive members of the community. We're ready to work toward any of a number of compromise solutions that will benefit the maximum number of citizens. Can Supervisor Wiener say the same thing? When things started to heat up, nudist leaders were eager to jump in and work toward a "win-win" solution. Supervisor Wiener stated that the only real catalyst for this controversy was a perceived congestion at Jane Warner Plaza and claimed the community was fed up. Clearly this seemed like a neighborhood concern, best answered by a local solution. Following a community meeting for Eureka Valley residents where relatively little negative input was actually aired (and even positive comments were made), Supervisor Wiener told several local nudist leaders that he was willing to "wait and see" if some self-policing by our ranks might improve the situation. He put that in writing to me as well because I had expressed sincere interest in the outcome. Just a few days after that, he went ahead and introduced the legislation! Where was the "waiting and seeing"? Clearly, this does not speak well to his desire to fairly serve his community. He has since stated more than once that he is confident the law will pass and I believe that kind of arrogance dismisses the importance of the community-based legislative process and, quite frankly, minimizes the voice of the other Board members.

Not being a San Francisco resident I realize my own voice may not be quite as compelling as others, but my love for the city is no less than anyone else's. My daughter lives there with her fiancé and my wife is a former resident of many years (Haight, Potrero, and Sunset). We spend considerable time in the city and love it for many reasons, not least of which is how socially evolved it has become. Please don't let this divisive and unnecessarily harsh legislation chip away at what truly makes San Francisco unique and special.

I'd welcome the chance to be a part of <u>any</u> dialogue that might be helpful, be it in person, by phone, or via any other method of communication. Thank you for listening!



My name is Gypsy Taub. I am the hostess of the nude TV series called "My Naked Truth" that airs in San Francisco on channel 29 on Saturdays at 10 PM.

I am writing to you today in response to the proposed nudity ban in San Francisco.

First off, there is a lot of misrepresentation going on around the issue of nudity. The claims that San Franciscans are against public nudity are simply not true, not even close. There is a very small minority of people who are indeed against it. But it is a very small minority. Any Supervisor supporting this bill is going against the wishes of the majority and is representing a minority or, rather, as it seems, a small special-interest group.

Have you ever tried walking down the streets of San Francisco nude? Well, I have. I once joined a so-called Freedom Walk, a nude walk in the city, with a few other urban nudists. I myself was amazed at the level of acceptance of nudity that I experienced that day. Our walk lasted about 4 hours, and during that whole time I only heard 2 negative remarks. That is not even 1% because we must have passed hundreds if not thousands of people. The weather channel filmed us and put us on the evening news — they were so enthusiastic about us being naked.

In my TV series called "My Naked Truth" I interview regular people nude (including older people, heavy people, disabled people etc...) It is not a porn contest neither is it a beauty contest, it's real conversations with real people. I've been producing the show for over 4 years. I have received a lot of feedback from the viewers, all overwhelmingly positive. I only got one negative comment in 4 years. I have to admit that I was expecting to hear a lot more negativity but I didn't.

When we did our nude walk it was so much fun! Many people took photos with us, exchanged contact info, cheered and waved and honked. The tourists were delighted beyond words. And I am not talking about men who just want to see aked women. I am talking about both men and women, tourists of all ages and nationalities, people who looked so ordinary – you would never suspect they were into nudism.

May be in some other places on this planet people are not ready for body freedom. But the city of San Francisco is not one of those places. I grew up in Moscow, and never thought I would ever call another city my home. But I now do call San Francisco my home. I am proud of my city. What I love the most here is the freedom that the people represent.

You can't stop progress, you can only delay it temporarily. Going back to the Dark Ages of body shame and sexual repression is not possible — no matter how hard some of us may try. I saw a great quote once that referred to the Arab Spring. It said: "You can crush the flowers but you can't stop the spring."

The Declaration of Independence states that we all have unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness. I strongly believe that body freedom is an unalienable right given to us all by our Creator, and that no human being has the right to take it away. The day will come when laws against nudity will be ruled unconstitutional, just as we recently witnessed the Supreme Court rule that discrimination against gay and lesbian couples is unconstitutional.

I encourage you to act in the name of progress and freedom. I encourage you to exercise true democracy where the political leaders represent the majority and not small special-interest groups. I encourage you to be true to the people of San Fracncisco. Please help us defeat the proposed Nudity Ban. Please kill this legislation! It deserves to die.

Im an electronics engineering student in Chile (south america) and hear about these topics is difficult in my daily environment. I consider myself a man of science but I'm extremely aware of the importance of the spiritual dimension in our lives. As you can guess, among engineering students these kind of thigs arent known and sometimes I feel kind of lonely in that area of my life.

I really love the interview that you did with Polly and her BF. My GF doesnt speak english so I was explaining her about Polly's extremely interesting experiences with masturbation/meditation. I've had similar experiences but I discover this coexistance between masturbation and meditation not too long ago so I dont have too much experience. If Polly could writte an article or even an ebook talking about her experiences and devoloping process would be totally amazing.

"As militant nudists, militant ONLY in the sense that we absolutely REFUSE to put on clothes or otherwise cover up our nudity, being nude in public is normal for us. Yes, we do also travel (nude of course) by car on cross-country vacations. We have camped in several National Parks

(and the park rangers have never hassled us) as well as driving to Burning Man in Nevada the last 4 years and we have driven to San Francisco the last 3 years for Bay to Breakers and also Folsom Street Fair. We enjoy walking around San Francisco nude, along with everywhere else along the way. We don't care if we get arrested, which as it turns out is harder to prosecute than the average streetcop might think and have chatted with cops on the street a number of times without being detained. If you have any requests of places in public here in our town you'd like to see of us, tell me and we'll go take some. We are comfortable nude EVERYWHERE and not afraid to go nude ANYWHERE. Additionally, we are both bisexual poly-amorous and enjoy a very open marriage with multiple partners from both sexes. — G and C, Missouri, USA"

"I enjoyed your interview with George Davis, but wanted Davis' and your thoughts about whether there is a relationship between sexual liberation and peace. I figured you both, standing there on television in your birthday suits, would have ideas about it.

A psychologist named James Prescott wrote an article which was published in the "Bulletin of the Atomic Scientist" in 1975, "Body Pleasure and the Origins of Violence." Prescott surveyed anthropological literature about pre-literate societies. He looked at three things: infant abuse or neglect, attitudes toward adolescent sexuality, and adult violence. Prescott found a correlation between adult violence, and both infant abuse/neglect, and repression of adolescent sex (he found a correlation, too, between neglect and abuse, as you might imagine).

Prescott writes, "Societies ranking high or low on the Infant Physical Affection Scale were examined for degree of violence. The results clearly indicated that those societies which give their infants the greatest amount of physical affection were characterized by low theft, low infant physical pain, low religious activity, and negligible or absent killing, mutilating, or torturing of the enemy. These data directly confirm that the deprivation of body pleasure during infancy is significantly linked to a high rate of crime and violence."

Also, "Premarital sexual freedom for young people can help reduce violence in a society, and the physical pleasure that youth obtains from sex can offset a lack of physical affection during infancy. Other research also indicates that societies which punish premarital sex are likely to engage in wife purchasing, to worship a high god in human morality, and to practice slavery." I'd forgotten the part about wife purchasing, but it's interesting in light of your conversation with George Davis.

""I came across your blogs tonight by accident and your videos gave me something to think about.

I am from Ireland, and I lived in the U.S. for about 8 years... I lived mostly in NY and San Francisco, but spent a lot of time in Arizona and Portland OR, too. I had to leave eventually in 2006 due to increased pressure because of my anti-war stance and my general disillusionment

with the whole American experiment/dream gone wrong. I found life in the post-9/11 US extremely repressive, I saw everything as going in the wrong direction.

I live in Germany now, and I am working on a book on my experiences during my last few years in the US... it's a period of American history I hope is not prolonged or repeated. Back in Europe, I don't have to worry about death threats for expressing my opinion. (Also in Europe, by the way, casual nakedness, psychotropic drug experimentation, and frank and intelligent discussions are quite normal).

In any case, know that you have an ally here, and I give you my full encouragement in what you are doing there.... get it out of the city! SF and NY are like enclaves of sanity in a dark continent, so bring some of that magical energy to the redneck wilderness of the great American pickup-truck-traversed expanse... And don't let anyone tell you that you're "brave" or you're "pushing the boundaries"... fuck the boundaries, they're a figment of some other assholes fragile imagination!
