10 MOVED, That the Board of Supervisors of the City and County of San Francisco
11 hereby amends Rule 5.1 of the Rules of Order of the Board of Supervisors to read as follows:

12 5.1 Budget and Finance Committee. The Budget and Finance Committee shall be
13 referred appropriation ordinances, and measures concerning bond issues, taxes, fees and
14 other revenue measures, redevelopment, and real estate. The Budget and Finance
15 Committee shall also be referred the annual appropriation and annual salary ordinances. The
16 Budget and Finance Committee shall hold a public hearing on the Mayor's budget instructions
17 to City Departments for each annual City budget after the instructions are released.

18 The Budget and Finance Committee shall be comprised of three full-time members
19 except that beginning on April 1 of each year the Committee shall be comprised of five
20 members and shall remain a Committee of five members until the Board of Supervisors
21 adopts the annual appropriation and salary ordinances. Following the adoption of the annual
22 appropriation and salary ordinances by the Board of Supervisors, the committee will be
23 reduced to the three full-time members.

24 Beginning on April 1 of each year, and until the Board of Supervisors adopts the annual
25 salary and appropriation ordinances, there shall be a subcommittee of the Budget and
Finance Committee consisting of three members. Unless otherwise designated by the

1 President, the members of the subcommittee shall be the full-time members of the Budget
2 and Finance Committee. The subcommittee may consider any matters assigned to the
3 Budget and Finance Committee except the annual appropriation and salary ordinances or the
4 Mayor's budget instructions.
