13 Must have a minimum of five years professional experience in the State of California as one of  
14 the following: Certified Public Accountant (CPA) or Public Accountant (PA); licensed Real  
15 Estate Broker; Attorney; or a Property Appraiser accredited by a nationally recognized  
16 professional organization, or Property Appraiser certified by the Office of Real Estate  
17 Appraisers; or he or she is a current member of an assessment appeals board. \*Pursuant to  
18 Section 1623 the three year term will end on the first Monday in September, for a three-year  
19 term ending September 2, 2013.

20 Alfredo Perez, seat 4, succeeding himself, term expired, must meet the eligibility  
21 criteria set forth in Section 1624.05 of the California Revenue and Taxation Code: Must have  
22 a minimum of five years professional experience in the State of California as one of the  
23 following: Certified Public Accountant (CPA) or Public Accountant (PA); licensed Real Estate  
24 Broker; Attorney; or a Property Appraiser accredited by a nationally recognized professional  
25 organization, or Property Appraiser certified by the Office of Real Estate Appraiser; or he or

1 she is a current member of an assessment appeals board. \*Pursuant to Section 1623 the  
2 three year term will end on the first Monday in September, for a three-year term ending  
3 September 2, 2013.
