7 hereby appoint the hereinafter designated persons to serve as members of the Shelter  
8 Monitoring Committee, pursuant to the provisions of Ordinance No. 283-04 and Article XII of  
9 Article 20 of the San Francisco Administrative Code, for the terms specified:

10 Judy Kerns, seat 2, succeeding Elihu Hernandez, resigned, must be homeless or  
11 formerly homeless within the 3 years prior to appointment with a disability, for the unexpired  
12 portion of a two-year term ending November 23, 2012.

13 Amanda Colson Heier, seat 4, succeeding Ramses Teon-Nichols, term expired, must  
14 be selected from a list of candidates that are nominated by community agencies that provide  
15 advocacy or organizing services to homeless people and be homeless or formerly homeless,  
16 for the unexpired portion of a two-year term ending November 23, 2012.

17 Maxine Pauson, seat 5, succeeding Diana Greer, resigned, must be selected from a list  
18 of candidates that are nominated by non-profit agencies that provide advocacy or organizing  
19 services to homeless people and be homeless or formerly homeless, for the unexpired portion  
20 of a two-year term ending November 23, 2012.

21 Will Daley, seat 6, succeeding Robert Weber, term expired, must be selected from a  
22 list of candidates that are nominated by non-profit agencies that provide advocacy or  
23 organizing services to homeless people, for the unexpired portion of a two-year term ending  
24 November 23, 2012.
