19 Dave Maass, seat 7, succeeding Lee Hepner, resigned, must be experienced in
20 consumer advocacy, for the unexpired portion of a two-year term ending April 27, 2018.

21 Frank Cannata, seat 8, succeeding Shaun Haines, term expired, must be a member of
22 the public who has demonstrated interest in, or has experience in, the issues of citizen access
23 and participation in local government, for the unexpired portion of a two-year term ending April
24 27, 2018.

1 Chris Hyland seat 9, succeeding themselves, term expiring, must be a member of the
2 public who has demonstrated interest in or has experience in the issues of citizen access and
3 participation in local government, for the unexpired portion of a two-year term ending April 27,
4 2018.

5 Louise Fischer, seat 10, succeeding themselves, term expired, must be a member of the
6 public who has demonstrated interest in or has experience in the issues of citizen access and
7 participation in local government, for the unexpired portion of a two-year term ending April 27,


