3 **Motion authorizing preparation of written Proponent ballot arguments and rebuttal**  
4 **ballot arguments for submittal to the voters at the June 7, 2016, Consolidated**  
5 **Presidential Primary Election.**

7 WHEREAS, The Board of Supervisors wishes to authorize the listed Board Member(s)  
8 supporting the following ballot measure(s) to prepare and submit a written proponent ballot  
9 argument(s) and proponent rebuttal argument(s) for submittal to the Director of Elections:

11 • Charter Amendment (Fourth Draft) to amend the Charter of the City and County of  
12 San Francisco to require an annual baseline appropriation for the Park, Recreation  
13 and Open Space Fund based on City spending for park and recreation purposes in  
14 FY2015-2016, extend the annual set-aside and the baseline appropriation for 15  
15 years to FY2045-2046, and modify the Recreation and Park Department's planning  
16 obligations to include equity analysis and Board of Supervisors review, at an  
17 election to be held on June 7, 2016. (Supervisor Farrell)

19 • Charter Amendment (First Draft) to amend the Charter of the City and County of  
20 San Francisco to authorize the Board of Supervisors to update the inclusionary or  
21 affordable housing obligations for housing development projects, and setting forth  
22 increased interim requirements; and affirming the Planning Department's  
23 determination under the California Environmental Quality Act, at an election to be  
24 held on June 7, 2016. (Supervisor Kim)

- 1 • Motion ordering submitted to the voters an Ordinance amending the Administrative  
2 Code to revise the City's Paid Sick Leave Ordinance (PSLO) to include protections  
3 for employees under the PSLO that largely parallel recent State law enactments  
4 pertaining to paid sick leave, primarily the Healthy Workplaces, Healthy Families  
5 Act of 2014, as amended, at an election to be held on June 7, 2016. (Mayor)

- 7 • Motion ordering submitted to the voters an Ordinance amending the Administrative  
8 Code to require the Office of Citizen Complaints to investigate all officer-involved  
9 shootings, at an election to be held on June 7, 2016. (Supervisor Cohen)  
10
- 11 • Ordinance calling and providing for a special election to be held in the City and  
12 County of San Francisco on Tuesday, June 7, 2016, for the purpose of submitting to  
13 San Francisco voters a proposition to incur the following bonded debt of the City  
14 and County: \$350,000,000 to finance the construction, acquisition, improvement,  
15 seismic strengthening and betterment of critical community and mental health,  
16 emergency response and safety, and homeless shelter and service facilities and  
17 related costs necessary or convenient for the foregoing purposes; authorizing  
18 landlords to pass-through 50% of the resulting property tax increase to residential  
19 tenants in accordance with Administrative Code, Chapter 37; finding that the  
20 estimated cost of such proposed project is and will be too great to be paid out of the  
21 ordinary annual income and revenue of the City and County and will require  
22 expenditures greater than the amount allowed therefor by the annual tax levy;  
23 reciting the estimated cost of such proposed project; fixing the date of election and  
24 the manner of holding such election and the procedure for voting for or against the  
25 proposition; fixing the maximum rate of interest on such bonds and providing for the

1 levy and collection of taxes to pay both principal and interest; prescribing notice to  
2 be given of such election; adopting findings under the California Environmental  
3 Quality Act ("CEQA"), CEQA Guidelines, and Administrative Code, Chapter 31;  
4 finding that the proposed bond is in conformity with the eight priority policies of  
5 Planning Code, Section 101.1(b), and with the General Plan, consistency  
6 requirement of Charter, Section 4.105, and Administrative Code, Section 2A.53;  
7 consolidating the special election with the general election; establishing the election  
8 precincts, voting places and officers for the election; waiving the word limitation on  
9 ballot propositions imposed by Municipal Elections Code, Section 510; complying  
10 with the restrictions on the use of bond proceeds specified in California Government  
11 Code, Section 53410; incorporating the provisions regarding the citizens' bond  
12 oversight committee in Administrative Code, Sections 5.30-5.36; and waiving the  
13 time requirements specified in Administrative Code, Section 2.34. (Mayor)

15 WHEREAS, The Board Member(s) authorized by this motion to submit the ballot  
16 arguments will submit the proponent argument to the Director of Elections no later than the  
17 deadline of noon, March 17, 2016, and the respective rebuttal ballot argument no later than  
18 noon, March 21, 2016; now, therefore, be it

19 MOVED, That the Board of Supervisors hereby authorizes the Board Member(s) listed  
20 above, under the provisions of Elections Code, Sections 530 and 550, to prepare and submit  
21 written proponent ballots argument and respective rebuttal ballot arguments on the listed  
22 measures; and, be it

23 FURTHER MOVED, That the Board Member(s) who are authorized by this motion to  
24 prepare and submit arguments, may authorize or assign to any other person(s) under the  
25

1 provisions of Elections Code, Sections 530 and 550 (c) and (d), the right to prepare and  
2 submit the proponent's ballot arguments and/or respective rebuttal arguments.


