

1 [Appointment, Food Security Task Force - Priti Rane]

3 **Motion appointing Priti Rane (residency requirement waived), for an indefinite term, to**
4 **the Food Security Task Force.**

5

6 MOVED, That the Board of Supervisors of the City and County of San Francisco does
7 hereby appoint the hereinafter designated person to serve as a member of the Food Security
8 Task Force, pursuant to the provisions of Health Code, Sections 470.1 and 470.2, for the
9 terms specified:

10 Priti Rane (residency requirement waived), seat 10, succeeding Maria LeClair,
11 resigned, must be from the Department of Public Health, Nutrition Services, for an indefinite
12 term; and, be it

13 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 14 1. The membership of the Food Security Task Force has a goal to be representative of
15 the diversity of the City and County of San Francisco.
- 16 2. Applicant Priti Rane, who is not a resident of San Francisco, is a person with
17 experience that uniquely qualifies her to serve on the Food Security Task Force.
- 18 3. The Food Security Task Force has attempted to fill the position, for which Priti Rane
19 was nominated, with an individual who is a City resident and who has the specific
20 experience, skills, and qualifications, but has been unable to do so at this time. The
21 Rules Committee has certified that Priti Rane is qualified to serve on the Food
22 Security Task Force.
- 23 4. After exercising due diligence, the Board of Supervisors concludes that there is no
24 other possible representative, who is a resident of San Francisco, and who has the
25

1 specific experience, skills, or qualifications possessed by this applicant, and who is
2 willing to serve on the Food Security Task Force at this time; and, be it

3 FURTHER MOVED, That the Board of Supervisors waives the residency requirement
4 for Priti Rane, as allowed in cases where no qualified City resident, willing to serve, can be
5 found, pursuant to Charter, Section 4.101(a)(2), that requires person(s) appointed to boards,
6 commissions, and advisory bodies established by legislative act of the Board of Supervisors
7 to be resident(s) of the City and County of San Francisco.
