AMENDING ORDINANCE NO. 184-99 TO REDEFINE UNDERGROUND DISTRICT NO 350 ON FOLSOM STREET FROM 16^{TH} STREET TO CESAR CHAVEZ STREET BY ADDING CERTAIN PROPERTY THERETO.

Be it ordained by the people of the City and County of San Francisco:

Section 1. In accordance with the provisions of Section 901, et seq. of Article 18, Chapter X, Part II of the San Francisco Municipal Code (Public Works Code), the Board of Supervisors does hereby create the following underground district:

Underground District No. 350

(Mid-Folsom Street District)

covering Folsom Street from 16th Street to Cesar Chavez Street and 23rd Street from Folsom Street to Treat Street.

Section 2. The undergrounding of facilities within this underground district is in the general public interest in that said action will eliminate a heavy concentration of overhead wires on a street that is extensively used by the general public and carries a heavy volume of pedestrian and vehicular traffic and an area adjacent to a park.

Section 3. All work in connection with the undergrounding of facilities lying within this underground district and subject to the laws with reference to underground districts is to be completed in accordance with the Department of Public Works' program; provided, however, that said work shall be commenced at such time or according to such priority as the Department of Public Works has established.

Section 4. The Board hereby requests that the utility companies providing the undergrounding of facilities within this underground district pay for up to 100 feet of each underground service lateral occasioned by the undergrounding.
