8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The San Francisco Traffic Code is hereby amended by adding Section 63.2,  
10 to read as follows:

11 **Sec. 63.2 Vehicles For Hire; Parking Prohibited In Certain Use Districts.**

12 It shall be unlawful for any vehicle for hire that is registered or required to be registered  
13 with the California Public Utilities Commission to park or leave standing, unless attended by  
14 the driver, any such vehicle in any street in a RH-1(D), RH-1, RH-2, RH-3, RH-4, RM-1, RM-  
15 2, RM-3, RM-4 or P Use District. Any person violating the provisions of the Section shall be  
16 guilty of an infraction and upon conviction thereon shall be punished by a fine of not less than  
17 ~~\$25 nor more than \$100.~~




