11 24, 2002. These settlements result in payment by the City in an undetermined amount not to  
12 exceed \$155,000; potential payment by the City of an additional amount to be determined;  
13 and an agreement on the maximum future water and sewer rate charges to plaintiffs for the  
14 next three fiscal years.

16 Be it ordained by the People of the City and County of San Francisco:

17 Section 1. The City Attorney is hereby authorized to settle the claims of plaintiffs  
18 Regents of the University of California and University of California, Hastings College of the  
19 Law in the following lawsuits: (1) Regents of the University of California v. City and County of  
20 San Francisco, San Francisco Superior Court Case No. 311005, filed March 24, 2000; (2)  
21 Regents of the University of California v. City and County of San Francisco, San Francisco  
22 Superior Court Case No. 324662, filed September 18, 2001; (3) University of California,  
23 Hastings College of the Law v. City and County of San Francisco, San Francisco Superior  
24 Court Case No. 400550, filed October 24, 2001; and (4) Regents of the University of

2 Francisco, San Francisco Superior Court Case No. 414027, filed October 24, 2002, by:

- 3 • the payment of an amount the exact amount of which remains to be determined by  
4 the parties, but not to exceed \$155,000;
- 5 • an agreement to pay a further amount should the final judgment on appeal of the  
6 order granting San Francisco a summary judgment in Regents of the University of  
7 California v. City and County of San Francisco, San Francisco Superior Court Case  
8 No. 311005 result in a reversal of the Superior Court's order as to the timeliness of  
9 the claims at issue in that action;
- 10 • an agreement by which charges for the capital component of plaintiffs' water and  
11 sewer service rates are limited according to a methodology agreed upon by the  
12 parties, for fiscal years 2003-04, 2004-05, and 2005-06.




