Ordinance amending the San Francisco Zoning Map by amending the lot reference applicable to 1717-17<sup>th</sup> Street, and an adjacent property, referred to as 495 DeHaro Street, so that the height district applicable to each lot in its entirety is 48-X and 45-X, respectively, in conformance with a lot line adjustment between the subject properties; and making various findings, including environmental findings and findings of consistency with the General Plan and priority policies of Planning Code Section 101.1.

Be it ordained by the People of the City and County of San Francisco: Section 1. Findings. The Board of Supervisors of the City and County of San Francisco hereby finds and determines that:

(a) Under Planning Code Section 302, the Board of Supervisors finds that this Ordinance will serve the public necessity, convenience and welfare for the reasons set forth in Planning Commission Resolution No. <u>18174</u> recommending the approval of this Planning Code Amendment and incorporates such reasons by this reference thereto. A copy of said Resolution is on file with the Clerk of the Board of Supervisors in File No. <u>100881</u> and is incorporated here by reference.

(b) Under Planning Code Section 101.1, the Board of Supervisors finds that this Ordinance is consistent with the Priority Policies of Planning Code Section 101.1(b) of the Planning Code and with the General Plan as proposed to be amended in companion legislation and hereby adopts the findings of the Planning Commission, as set forth in Planning Commission Resolution No. <u>18174</u>. A copy of said Resolution is on file with

the Clerk of the Board of Supervisors in File No. \_\_\_\_\_\_ and is incorporated herein by reference.

(c) The Planning Department also determined that the actions contemplated in this Ordinance are in compliance with the California Environmental Quality Act (California Public Resources Code sections 21000 et seq.). A copy of said determination is on file with the Clerk of the Board of Supervisors in File No. <u>100881</u> and is incorporated by reference herein.

(d) The purpose of this legislation is to ensure that the height districts applicable to two properties commonly known as 1717 17<sup>th</sup> Street (Assessor Block 3980, Lot 08) and 495
DeHaro Street or portion thereof (Assessor Block 3980, Lot 09) conform with the underlying lot pattern that resulted from a lot line adjustment between the subject properties.


