The use of commercial paper shall be repaid from the proceeds of the Certificate of Participation issuance in a subsequent period.

Section 4. The uses of funding outlined above for \$38,000,000 are herein placed on Controller's Reserve for Fiscal Year 2010-2011 pending issuance of the Certificates of Participation. The Controller is authorized to release up to \$2,000,000 of proceeds of commercial paper used in the interim period.

Section 5. The Controller is authorized to record transfers between funds and adjust the accounting treatment of sources and uses appropriated in this ordinance as necessary to conform with Generally Accepted Accounting Principles.
