
3 **Ordinance providing revenue and levying property taxes for San Francisco Community**

6 Be it ordained by the People of the City and County of San Francisco:

7 **SECTION 1.** Under and pursuant to the law of the State of California and in conformity  
8 therewith a tax is hereby levied for San Francisco Community College District purposes for  
9 fiscal year ending June 30, 2012 on all property, real and personal in the City and County of  
10 San Francisco, except such property as is by law exempt from taxation, in the sum of \$0.0340  
11 on each \$100.00 valuation of said taxable property as the same appears upon the secured  
12 assessment roll of the said City and County for said fiscal year, which said sum is hereby  
13 apportioned as follows;


