Section 1. The City Attorney is hereby authorized to settle the action entitled "Local Search Association v. City and County of San Francisco, et al., United States District Court for the Northern District of California, Court No. CV-11-2776 SBA by stipulating to the entry of a consent judgment against the City and County of San Francisco providing as follows: the parties dispute whether San Francisco Ordinance No. 78-11 was constitutional at the time it was enacted but they agree that it is unconstitutional and may not be enforced under Dex Media West Inc. v. City of Seattle, 696 F.3d 952 (9th Cir. Oct. 15, 2012); and the City and County of San Francisco will pay \$85,000 in attorneys' fees and costs to Local Search Association.

Section 2. The above-named action was filed in the United States District Court for the Northern District of California on June 7, 2011, and the following parties were named in the lawsuit: plaintiff Local Search Association and defendants City and County of San Francisco; Board of Supervisors of the City and County of San Francisco; and Edwin M. Lee in his official capacity as Mayor of the City and County of San Francisco.
