15 Be it ordained by the People of the City and County of San Francisco:

16 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
17 authorizes the City Attorney to settle the actions entitled Justice Investors LP, Justice
18 Operating Co. LLC v. City and County of San Francisco, San Francisco Superior Court Case
19 No. CGC-15-546897, and Justice Investors LP, Kearny Street Employers LLC v. City and
20 County of San Francisco, San Francisco Superior Court Case No. CPF-15-514532, by the
21 payment of \$1,450,000 and San Francisco's dismissal of its cross-complaint in Case No.
22 CPF-15-514532. These are suits for refund of Real Property Transfer Tax, Transient
23 Occupancy Tax and Tourism Improvement District Fees.

24 Section 2. The above-named actions were filed in San Francisco Superior Court on
25 July 16, 2015 and October 19, 2015, respectively, and the following parties were named in the


1 lawsuits: as plaintiffs, Justice Investors LP, Justice Operating Co. LLC, Kearny Street


