

1 [Liquor License Modification, 536 Golden Gate Avenue]
2 RESOLUTION DETERMINING THAT THE REQUEST TO REMOVE ALL CONDITIONS
3 ON A TYPE 47 ON-SALE GENERAL EATING PLACE CONDITIONAL ALCOHOLIC
4 BEVERAGE CONTROL LICENSE FOR SONTHI AND MAY ONGBHAIBULYE,
5 OWNERS OF KITES LOCATED AT 536 GOLDEN GATE AVENUE, IS JUSTIFIED
6 UNDER THE PROVISIONS OF SECTION 23803 OF THE CALIFORNIA BUSINESS

9 WHEREAS, Sonthi and May Onghaibulye owners of Kites located at 536 Golden
10 Gate Avenue, is seeking the removal of all conditions on their Type 47 on-sale general
11 eating place conditional alcoholic beverage control license; and,

12 WHEREAS, The Department of Alcoholic Beverage Control transmitted a letter
13 dated April 20, 2000 asking the San Francisco Board of Supervisors to remove all
14 conditions, which letter is on file with the Clerk of the Board of Supervisors in File No.
15 000766, which is hereby declared to be a part of this resolution as if set forth fully
16 herein; and,

17 WHEREAS, The City Planning Department has verified that the area is properly
18 zoned; and that the modification can be approved; and

19 WHEREAS, The Police Department recommends the approval of the removal of
20 all conditions on the Type 47 on-sale general eating place conditional alcoholic
21 beverage control license; now, therefore, be it

22 RESOLVED, That in accordance with Section 23803 of the California Business
23 and Professions Code, the Board of Supervisors of the City and County of San
24 Francisco hereby determines to approve the request of Sonthi and May Ongbhaibulye
