20 Francisco hereby determines to approve the request of Adnan Daher and Marlaine
21 Butros to modify the Type 21 off-sale general conditional alcoholic beverage control
22 license to modify condition 1, to change the hours of operation from 8:00 to 10:00 p.m.
23 to 8:00 a.m. to midnight.


