2 AUTHORIZING THE DEPARTMENT OF THE DISTRICT ATTORNEY TO ACCEPT AND
3 EXPEND A GRANT IN THE AMOUNT OF \$574,853 FROM THE OFFICE OF CRIMINAL
4 JUSTICE PLANNING FOR A PROJECT ENTITLED THE VICTIM WITNESS ASSISTANCE
5 PROGRAM ("VWAP").

7 WHEREAS, the City and County of San Francisco desires to
8 continue a certain project designated the Victim Witness Assistance
9 Program to be funded in part from funds made available through the
10 California Office of Criminal Justice Planning (OCJP); and,

11 WHEREAS, this project provides assistance to victims of crime
12 committed in the City and County of San Francisco or against City
13 residents; and,

14 WHEREAS, the Department proposes to maximize use of available
15 grant funds on program expenditures by not including indirect costs
16 in the grant budget; now, therefore, be it

17 RESOLVED, That the District Attorney of the City and County of
18 San Francisco is authorized to submit the attached proposal to OCJP
19 and is authorized to sign and approve on behalf of the City and
20 County of San Francisco the attached Grant Award Agreement including
21 any extensions or amendments; and be it,

22 FURTHER RESOLVED, That the Board of Supervisors hereby waives
23 inclusion of indirect costs in the grant budget; and be it

24 AGREED, That any liability arising out of the performance of the
25 Grant Award Agreement, including civil court actions for damages,

1 shall be the responsibility of the grant recipient and the
2 authorizing agency. The State of California and OCJP disclaim
3 responsibility for any such liability; and be it


4 FURTHER RESOLVED, That the applicant agrees to provide all

8 FURTHER RESOLVED, That grant funds received hereunder shall not




