1 **URGING THE SAN FRANCISCO DEPARTMENT OF PARKING AND TRAFFIC TO INSTALL**  
2 **SPEED HUMPS ON HAMPSHIRE STREET BETWEEN EIGHTEENTH AND NINETEENTH**

6 WHEREAS, Residents in the north eastern part of the Mission district especially within  
7 the area of Hampshire, York and Portrero bounded by Eighteenth and Nineteenth Streets;

9 WHEREAS, There is frequent speeding of cars and car racing along this area,  
10 especially on Hampshire Street between Eighteenth and Nineteenth Streets; and

11 WHEREAS, Residents and merchants are concerned about pedestrian safety,  
12 especially children and seniors that live in the neighborhood; and

13 WHEREAS, Neighbors have expressed their desire for the City to take measures to  
14 address the issue of pedestrian and traffic safety in the area, especially the installation of  
15 speed bumps along Hampshire Street ; now therefore be it

16 **RESOLVED**, That the Board of Supervisors of the City and County of San Francisco  
17 urge the Department of Parking and Traffic to install speed humps on Hampshire Street  
18 between Eighteenth and Nineteenth Streets as well as other traffic calming measures in order  
19 to promote pedestrian safety in the neighborhood.


