

1 [Agreement of Sale]

2 Resolution authorizing and approving the agreement of sale of a permanent non-
3 exclusive easement of City-owned property located in an unincorporated area of
4 San Mateo County being a portion of Lot 9, Assessor's Block 23, located near
5 Esther Lane and Hillcrest Drive, near Redwood City, in the Oak Knoll Manor
6 District to the County of San Mateo.

9 WHEREAS, City owns an approximate 697 square foot plot of land known as Parcel
10 Reference Number 2895 Bay Division Pipelines 1 and 2, adjacent to City and County of
11 San Francisco Right-of-way in an unincorporated section of San Mateo County; and

12 WHEREAS, City gave San Mateo County a revocable permit to install and
13 maintain a six inch sewer line to cross through Parcel Reference Number 2895 Bay
14 Division Pipelines 1 and 2 in December 1971; and

15 WHEREAS, This parcel of land is under the jurisdiction of the San Francisco
16 Public Utilities Commission and is surplus to their needs, and

18 WHEREAS, City has agreed to sell and the County of San Mateo has agreed to
19 purchase the southeasterly 10 foot width of land of this irregularly shaped parcel for
20 \$5,000 which has been determined to be the fair market value of these easement rights,
21 and subject to the terms and conditions in the "Easement Agreement", a copy of which is
22 on file with the Clerk of the Board of Supervisors in File No. 010734; and

1 WHEREAS, San Francisco Public Utilities has authorized the sale of this non-
2 exclusive easement to the County of San Mateo by Public Utilities Commission
3 Resolution No. 01-0048 on February, 27, 2001; and

4 WHEREAS, The County of San Mateo has authorized the purchase of this non-
5 exclusive sewer easement to provide a public benefit by Resolution No. 64346 on April
6 4, 2001 for \$5,000; now therefore, be it

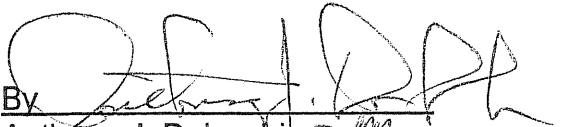

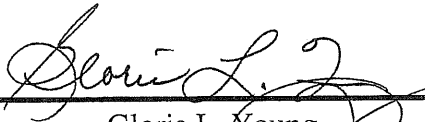
