8 WHEREAS, The San Francisco Department of Public Health (SFDPH) has
9 applied for and been awarded a grant from the California Business, Transportation &
10 Housing Agency Office of Traffic Safety (CBTHAOTS) in the amount of \$798,353 for a
11 two year project to reduce motor vehicle and pedestrian fatalities and injuries in San
12 Francisco; and,

14 WHEREAS, As a condition of receiving the grant funds, CBTHAOTS requires the
15 City to enter into an agreement (the "Agreement"), a copy of which is on file with the
16 Clerk of the Board of Supervisors in File No. 011097, which is hereby declared to
17 be a part of this resolution as if set forth fully herein; and,

19 WHEREAS, The grant budget includes provision for indirect costs of \$24,946;
20 now, therefore, be it

22 RESOLVED, That the SFDPH is hereby authorized to accept and expend the
23 grant funds in accordance with the requirements set forth in the Agreement, pursuant
24 to San Francisco Administrative Code section 10.170-1; and be it

FURTHER RESOLVED, That the Controller is directed to designate the positions created under the grant as "G" or grant-funded positions, which would terminate when the grant expires; and, be it






