WHEREAS, The California Department of Social Services (CDSS) has continued service level as part of its general welfare reform legislation ("CalWORKS") for CalWORKS Stages I and II; and,

WHEREAS, CDSS and state CalWORKS are funding numerous capacity building initiatives and,

WHEREAS, The Board of Supervisors of the City and County of San Francisco has approved appropriation for city subsidies; and,

WHEREAS, The Children's Council of San Francisco is under contract to the City and County of San Francisco has provided this type of service successfully for several years, and is the largest single provider of these services in the City and County of San Francisco; and,

WHEREAS, Under its existing contract, effective July 1, 2000, and continuing until June 30, 2001, for the total amount of \$32,817,700, Children's Council of San Francisco is the largest single provider of the services covered by this legislation, namely the provision of Child Care support to families who are moving from welfare to work; and,

WHEREAS, For purposes of efficiency and to maximize the amount of child care that can be provided to eligible participants in funded programs, funds should be consolidated and administered by Children's Council of San Francisco; and,

WHEREAS, On June 21, 2001, the Human Services Commission approved the agreement with Children's Council of San Francisco, as proposed herein; therefore be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco authorizes the execution of a renewal of this agreement with the Children's Council of San Francisco, effective August 1, 2001 through June 30, 2003, in the amount of \$72,922,718; and, be it

FURTHER RESOLVED, That the Executive Director of the Department of Human Services is authorized to sign the contract for the City and County of San Francisco.
