13 care to uninsured low-income women, worked to increase state and  
14 federal research budgets, and funded research into non-toxic

16 WHEREAS, Andrea R. Martin has expanded The Breast Cancer Fund's  
17 mission to include the discovery and elimination of environmental  
18 causes of this dreaded disease; and,

19 WHEREAS, Andrea R. Martin suffers from breast cancer as well as  
20 a malignant brain tumor and is facing this struggle with remarkable  
21 courage; and,

22 WHEREAS, After heart disease, cancer is the second leading cause  
23 of death among women in San Francisco, and Andrea R. Martin's efforts  
24 to reduce and eventually eliminate breast cancer have been a great  
25 service to our City and the Nation; now, therefore, be it

1       RESOLVED, That the Board of Supervisors of the City and County  
2 of San Francisco hereby commends Andrea R. Martin for her outstanding  
3 advocacy on behalf of women suffering from breast cancer and wishes  
4 her success in her on going personal struggle with cancer.




