WHEREAS, The grant budget includes provision for indirect costs of \$32,008; now, therefore, be it

RESOLVED, That the SFDPH is hereby authorized to accept and expend retroactively a grant in the amount of \$1,105,000 from SAMHSA/CSAT; and, be it

FURTHER RESOLVED, That the SFDPH is hereby authorized to accept and expend the grant funds in accordance with the requirements set forth in the Agreement pursuant to San Francisco Administrative Code section 10-170-1; and, be it

FURTHER RESOLVED, That the Director of Health is authorized to enter into the Agreement on behalf of the City; and, be it

FURTHER RESOLVED, That the Controller is directed to designate the positions created under the grant as "G" or grant-funded positions, which would terminate when the grant expires.
