3 **Resolution appointing Richard Castro and Carl Rose, terms ending June 30, 2003, to**
4 **the Asthma Task Force, residency requirement waived.**

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
7 does hereby appoint the hereinafter designated person to serve as a member of the Asthma
8 Task Force, pursuant to the San Francisco Administrative Code, Chapter 19A, Article II, for
9 the term specified:

10 Carl Rose (residency requirement waived), succeeding Ben Loewy, seat 13, must be a
11 representative of lung health/asthma-specific organization, for the unexpired portion a two-
12 year term ending June 30, 2003;

13 Richard Castro, succeeding John Balmes, seat 19, must be an individual who is an
14 academic researcher or educator concerned with asthma issues, for the unexpired portion a
15 two-year term ending June 30, 2003; and, be it

16 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 17 1. The membership of the Asthma Task Force has a goal to be representative of the
18 diversity of the City and County of San Francisco.
- 19 2. Applicant Carl Rose, a new appointee, who is not a resident of San Francisco, is a
20 person with experience that uniquely qualifies him/her to serve on the Asthma Task
21 Force.
- 22 3. The Asthma Task Force has attempted to fill the position, for which Carl Rose was
23 nominated, with an individual who is a City resident and who has the specific
24 experience, skills, and qualifications, but has been unable to do so at this time. The

After exercising due diligence, the Board of Supervisors concludes that there is no other possible representative, who is a resident of San Francisco and who has the specific experience, skills, or qualifications possessed by this applicant, and who is willing to serve on the Asthma Task Force at this time; and, be it

FURTHER RESOLVED, That the Board of Supervisors waives the residency requirement for Carl Rose, as allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed to boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.


