3 **Resolution determining that the issuance of a Type 20 off-sale beer and wine**  
4 **alcoholic beverage control license to Joel Bleskacek and John David-Malone, for**  
5 **Potrero Market located at 1419 – 18<sup>th</sup> Street (District 10), will serve the public**  
6 **convenience and necessity of the people of the City and County of San**  
7 **Francisco, in accordance with Section 23958.4 of the California Business and**  
8 **Professions Code, with conditions.**

10 WHEREAS, Joel Bleskacek and John David-Malone are seeking issuance of a  
11 Type 20 off-sale beer and wine alcoholic beverage control license for Potrero Market,  
12 located at 1419 – 18<sup>th</sup> Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly  
14 zoned; and

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the issuance of a Type 20  
20 off-sale beer and wine alcoholic beverage control license, to Joel Bleskacek and John  
21 David-Malone for Potrero Market, located at 1419 – 18<sup>th</sup> Street (District 10), will serve  
22 the public convenience and necessity of the people of the City and County of San  
23 Francisco.

24 Conditions: (1) Sales and service of alcoholic beverages shall be permitted only  
25 between the hours of 10:00 a.m. and 9:00 p.m. each day of the week; (2) No wine shall

1 be sold with an alcoholic content greater than 15% by volume except for "Dinner Wines"  
2 which have been aged two years or more and maintained in corked bottles; (3) Beer,  
3 malt beverages, and wine coolers in containers of 12 oz. or less cannot be sold by  
4 single containers, but must be sold in manufactured pre-packaged multi-unit quantities;  
5 and (4) The petitioner shall be responsible for maintaining free of litter the area in front  
6 of and adjacent to the premises over which they have control.




