WHEREAS, In October of 1999, The San Francisco Board of Supervisors passed Resolution No. 905-99 urging that carsharing become a component of the City's "Transit First" policy and urging various City departments to aid in the development and administration of the City Carshare; and,

WHEREAS, In September of 2000 the City and County of San Francisco executed a grant agreement with City Carshare, approved by the Board of Supervisors and on file with the Clerk of the Board of Supervisors in File No. 021939, which is hereby declared to be a part of this resolution as if set forth fully herein; and

WHEREAS, This grant agreement included a two year pilot program to facilitate the growth of City Carshare by providing spaces free of charge in various city-owned garages; and,

WHEREAS, City Carshare has exceeded its expectations in generating interest in their program, providing members with access to shared vehicles on a low cost pay-per-use basis; and

1 WHEREAS, Independent studies have demonstrated a substantial public benefit, that
2 is anticipated to continue, by reducing the need for individual car ownership, thus lowering the
3 number of vehicles on city streets; and

4 WHEREAS, The City and County of San Francisco is committed to ensuring the
5 continued success of this program; now, therefore, be it

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
7 authorizes the Director of Transportation of the Municipal Transportation Agency, or his or her
8 designee, to enter into a Second Amendment to the grant agreement between the City and
9 County of San Francisco and City Carshare on file with the Clerk of the Board of Supervisors
10 in File No. 021939, which is hereby declared to be a part of this resolution as if set forth
11 fully herein, extending the term of the agreement by six months to June 30, 2003 and
12 providing existing spaces free of charge in city-owned garages for car-sharing.


